WEEKLY CRIME REPORT



MAY 27TH - JUNE 2ND, 2024

ALPHA ZONE

LARCENY

Walmart, 11 Village Parkway, deputy responded to a larceny in the toy aisle. Staff advised a 17-year-old female was attempting to steal \$60 worth of Hot Wheels and Matchbox cars. The car fan would receive a criminal complaint for shoplifting.

Walmart, 11 Village Parkway, deputy responded to a larceny. Staff advised a female suspect was caught attempting to steal nearly \$300 worth of items. The 59-year-old admitted she did come to steal and was issued a summons for larceny.

VANDALISM

Limestone Way, deputy responded to a vandalism. The victim advised her vehicle had paint dumped on it. The unwanted paint job was captured on camera.

Bunker Lane, deputy responded to a vandalism. The victim advised a family member broke multiple glass items within the residence due to her cell phone services being suspended for punishment for not doing the dishes. A permitted warrant for the destruction of property was obtained.

Briggs Lane, deputies responded to a vandalism. The victim advised he had a verbal altercation with a neighbor earlier in the day. In retaliation for the disagreement, the suspect would vandalize the victim's camper and assault him. The suspect was discovered to be wanted out of Stafford County for two (2) counts of animal cruelty. He was charged with assault and battery, destruction of property, and served on his outstanding warrants. He was held at Rappahannock Regional Jail on a \$10,000 secured bond.

HIT AND RUN

Dominion Energy, 980 Warrenton Road, deputy responded to a disturbance. The caller advised a victim ran into the business claiming her ex-boyfriend was chasing her down Warrenton Road. The caller would witness the "ex" strike the victim's vehicle twice before fleeing the scene. He would return, this time with a hammer. The suspect was located next door attempting to eat more chicken at Chick-Fil-A. He was charged with destruction of property, hit and run, disorderly conduct, and reckless driving. He was held at Rappahannock Regional Jail without bond.

Target, 25 South Gateway Drive, deputy responded to a hit and run. The victim advised another vehicle struck and damaged her vehicle while she was in it. Luckily, a witness was able to obtain the suspect vehicle's license plate.

BRAVO ZONE

PUBLIC INTOXICATION

Payton Drive, deputy responded to an unknown problem. The caller advised an unknown female was sitting in his yard who appeared disoriented. The deputy located the suspect, who did not know where she was, in an intoxicated state. While the suspect denied consuming drugs, sitting next to her was suspected controlled substances. She would later advise that her drug of choice was heroin. She was charged with two (2) counts of possession of controlled substances and public intoxication. She was held at Rappahannock Regional Jail pending her ability to participate in a bond hearing.

Chatham Bridge, deputy responded to an intoxicated person call. The caller advised a female was staggering on the bridge and smelled like alcohol. The deputy arrived and made contact with the now-singing suspect. Her solo was cut short due to her extremely intoxicated state. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

DUI

McDonald's, 316 Butler Road, deputy observed a revoked driver behind the wheel and made contact with him. The driver acted as if he did not know his license was not valid and he was out for a nugget run. His McNuggets would have to wait, the deputy observed several signs of intoxication. The driver advised he consumed a mixed drink; however, was unsure how much alcohol was truly in it. He was charged with driving under the influence and driving while revoked. The driver was not loving it when he was held at Rappahannock Regional Jail without bond.

Deacon Road, deputy responded to an auto accident. Dispatch received an automatic crash notification from a Honda. It was discovered a vehicle crashed into the median. The driver had signs of intoxication, admitted to consuming alcohol prior to driving, and multiple cans of alcohol were located in the vehicle. Thanks to her Honda tattling on her, the driver was charged with driving under the influence. She was held at Rappahannock Regional Jail on a \$2,000 secured bond.



CHARLIE ZONE

PUBLIC INTOXICATION

2000 Block of Courthouse Road, deputy responded to an intoxicated person call. The caller advised a male who appeared "very intoxicated" was in his driveway. When the deputy arrived in the area, she quickly located the suspect due to him walking in the middle of the road, and his Hawaiian shirt. The suspect had signs of intoxication and admitted to consuming alcohol at a party. Suspect was charged with public intoxication and held until sober.

Woodspring Suites, 1006 Corporate Drive, deputy responded to a disturbance. Staff advised a male was in the lobby drooling, screaming, and banging on the wall to the point that his hands were bloody. When the deputy arrived, the suspect appeared to be hallucinating as he rolled around on the ground. A witness advised the suspect took cocaine, further proving just how dangerous drugs are. The suspect was found with a smoking device that had suspected controlled substances in it. The suspect was charged with public intoxication and possession of controlled substances. He was held at Rappahannock Regional Jail pending his ability to participate in a bond hearing.

Stafford Hospital, 101 Hospital Center Boulevard, deputy responded to an intoxicated assault. A female from a previous incident earlier in the evening was being treated when she assaulted two (2) nurses. She would then barricade herself in the bathroom. The bathroom barricade ended and the suspect was charged with public intoxication, two (2) counts of assault and battery on health care workers, as well as, disorderly conduct.

Munsons Hill Court, deputy responded to a disturbance. The victim advised an unknown female and child entered his house as he was cooking. He further advised the female appeared intoxicated. The deputy located the child and suspect, who was intoxicated. The suspect advised she and her child walked miles to Lakeview Court, where she thought she currently was. She was taken into custody while a responsible and sober guardian responded to take care of the child. At the magistrate's office, the suspect would continuously cause disturbances. She was charged with public intoxication, child neglect, unlawful entry, and obstruction of justice.

ASSAULT

Genesis Logistics, 705 Bradburn Place, deputy responded to Genesis Logistics for an assault. Staff advised they were removing an employee due to an internal investigation when that employee decided he wasn't going to leave quietly. The suspect assaulted his supervisor. Not only is it unlikely he will be returning to work there he also received a permitted warrant for assault and battery.

DUI

3600 block of Richmond Highway, deputy responded to a single-vehicle auto accident. It was discovered a truck traveling Northbound lost control, and crossed into the Southbound lanes before ending its journey in a ditch. The driver had signs of intoxication and admitted to consuming approximately eight (8) beers before driving. If the driver wasn't in trouble enough already, he would provide a false identity. He was charged with driving under the influence, driving without a driver's license, driving without insurance, providing a false identity to law enforcement, and reckless driving.

DELTA ZONE

ASSAULT

Susan Street, deputy responded to an assault. It was discovered a male and female were engaged in a disagreement over personal matters when a neighbor interjected himself into the argument. This unwanted 3rd party would assault the male. The incident was captured on camera. A permitted warrant for assault and battery was obtained.

LARCENY

Target, 1090 Stafford MarketPlace. Well aware of how much shoplifters love stealing from Target, members of the Special Problems Unit conducted an anti-shoplifting detail. During the detail, deputies observed a male suspect concealing boxes of Bud Light in a tote and only paying for a bow. While bows normally go on presents, this one ended up on the suspect's summons for shoplifting.

Walmart, 14 North Stafford Complex Center, deputy responded to a larceny. A witness advised he observed a male suspect walk out with a cart full of alcohol. When the suspect noticed his shoplifting didn't go unnoticed, he abandoned the stolen goods and fled the area. The cart full of alcohol that would rival most Fourth of July parties was returned.

Walmart, 217 Garrisonville Road, deputy responded to a larceny. The victim advised while shopping she accidentally left her wallet in the store. She would later remember her mistake when she got a notification that her card was being used. While the transaction was denied, the suspect attempted to buy a new laptop courtesy of the victim. The suspect was identified using store cameras and warrants were obtained.

ABC Store, 1630 PublixWay, deputies responded to a fraud. It was discovered that two (2) male suspects paid for whiskey using a fake \$100 bill and received "real cash" in return. It was also discovered that the pair would do the same at Abner B's Ice Cream, paying for two (2) ice cream bowls and getting "real cash" in return.

Sheetz, 1175 Garrisonville Road, deputy responded to a beer bandit. Staff advised a male suspect walked out with two (2) cases of beer.

Autozone, 1167 Garrisonville Road, deputy responded to a larceny. Staff advised that a group of people were "in the zone" and stole over \$2,900 worth of items.

Kohl's, 1220 Stafford Market Place, deputy responded to a larceny. Staff advised a male suspect stole a fragrance set.

Lotus Lane, deputy responded to a larceny. The victim advised FedEx dropped off a package containing multiple iPhones. Three minutes later, an unknown male pulled up in a silver SUV, sprinted to the victim's porch, and stole the box. The incident was captured on camera.

Target, 1090 Stafford Market Place, deputy responded to a larceny. Staff advised that an elderly lady came to pick up her prescriptions and, in the process, took a cookware set valued at approximately \$280. The suspect was quickly identified and it was discovered that this was not her first time stealing on a prescription run. A warrant for larceny will be obtained.

DELTA ZONE

PUBLIC INTOXICATION

Buffalo Mo's, 33 Wicomico oDrive, deputy responded to an intoxicated person call. Staff advised there were two (2) unconscious females lying in the grass. When deputies arrived, one of the suspects awoke from her grassy bed and advised she consumed Fireball "along with other drinks." She was charged with public intoxication and held at Rappahannock Regional Jail until sober. The other female was transported to Stafford Hospital due to her level of intoxication.

The Corner Garden Center, 508 Garrisonville Road, deputy responded to an intoxicated person call. The caller advised that there was a very "fidgety" male talking loudly to himself. The deputy made contact with the suspect, who had signs of intoxication, two (2) bottles of an alcoholic beverage on his person, and thought he was in Maryland. He was informed that this is Stafford County and was charged with public intoxication. He was held at Rappahannock Regional Jail until sober.

ALCOHOL OFFENSE

Lowe's, 1330 Stafford Market Place, deputy was driving in the area when a juvenile stumbled across the road in front of him. Wanting to answer the age-old question of "why did the juvenile cross the road," the deputy made contact with him. The 16-year-old was intoxicated and was in possession of Buzz Balls. His parents got an early wake-up call to pick up their son and a criminal complaint for underage possession of alcohol was submitted.

Renee Road, deputy responded to a report of an assault. While investigating the claims, he made contact with a male suspect surrounded by multiple beer cans. If that wasn't a clue regarding public intoxication, the odor of an alcoholic beverage coming from the suspect's breath and the fact that he would ask the same two questions every five minutes were. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

DUI

Wawa, 920 Wonder Road, deputy responded to the new Wawa for an old problem. The caller advised that the driver of a Mustang appeared intoxicated. The deputy located the Mustang driver and observed signs of intoxication. The driver also advised that he consumed beer at a bar on Wicomico Drive. He was charged with driving under the influence with a blood alcohol content between .15 and .2. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

Queen Beauty, 395 Garrisonville Road, deputy responded to a larceny. Staff advised a female suspect stole 11 bundles of hair extensions before fleeing in a black Acura. The deputy located the suspect vehicle, conducted a traffic stop, and identified the Rapunzel fan who still had possession of the stolen hair. The Norfolk woman was issued a summons for larceny.

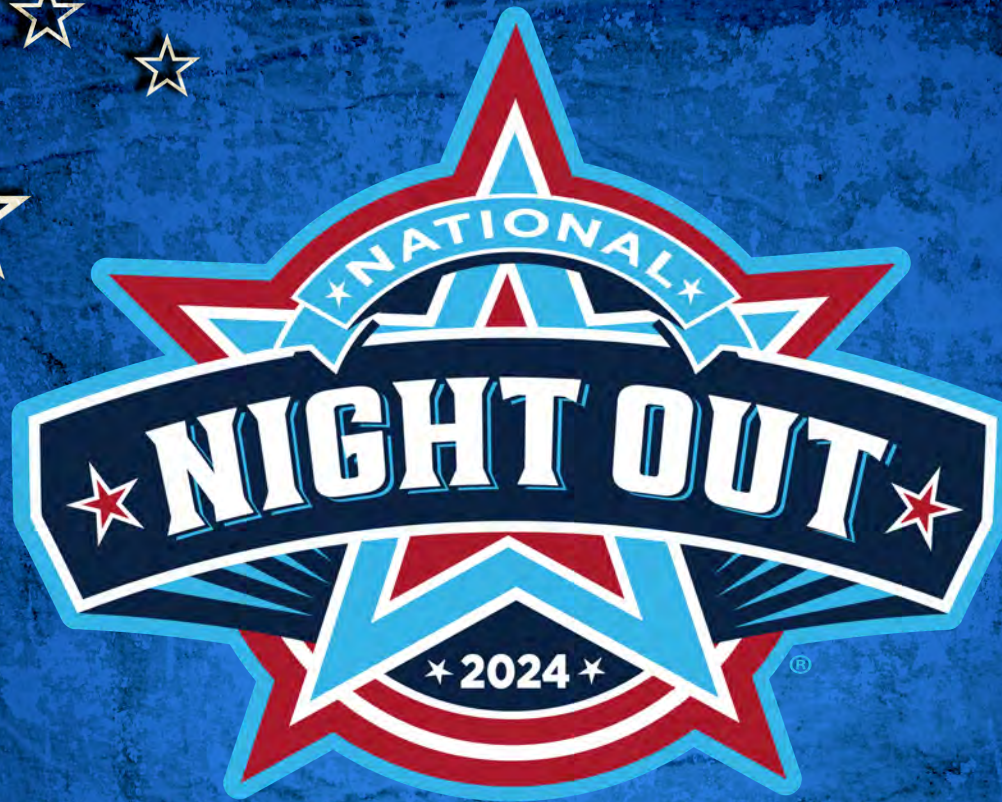


SCAM-AWARE



Victim received an email from Norton saying that he owed them money. He said he called the number on the email (313-636-9500), and spoke with an individual who identified themselves as "Ryan". "Ryan" told the victim that he resolved the issue on the payment for Norton, but accidentally refunded him too much money equaling \$4,000 to the victim's bank account. "Ryan" told the victim he was a new employee and that he would get in trouble for refunding that much money so he asked the victim to go to stores to buy gift cards to make the balance even. The victim had bought cards for a total of approximately \$3000.

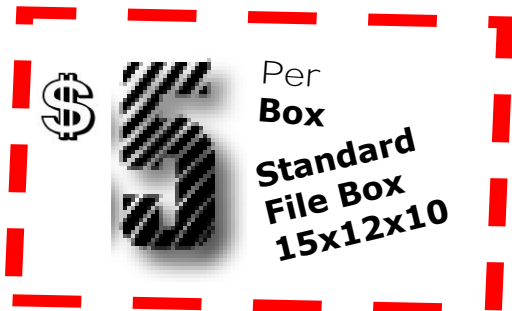
