

**Boxelder Drive** Embrey Mill 05/30/23 05/30/23 Fraud: SCAM: Victim was texting with an unknown individual on Snapchat; "Sharon alana7". The victim oddly received an email stating their credit card with Capital One had been paid off by "Sharon Alana." Victim checked their Capital One account and it had in fact been paid off. Soon thereafter, the victim received a message from "Sharon\_alana7" asking for the victim to purchase her Apple gift cards since she did the victim a favor; the victim said no. The following day, the victim received emails from "fluxup77@gmail.com" stating if the victim did not purchase the Apple gift cards, the victim's life would be ruined financially. Victim proceeded to purchase three (3) \$500 Apple gift cards and provided the information via Snapchat to "Sharon Alana7". Victim continued to receive requests for "additional gift cards or experience financial ruin." Victim checked all their financial accounts and ensured proper security measures were set to prevent fraud, and then proceeded to contact and report the scam to the Stafford County Sheriff's Office. Monetary loss of \$1,500. 15 Eustace Road 05/31/23 Wawa Larceny: Shoplifting (X2.) 


