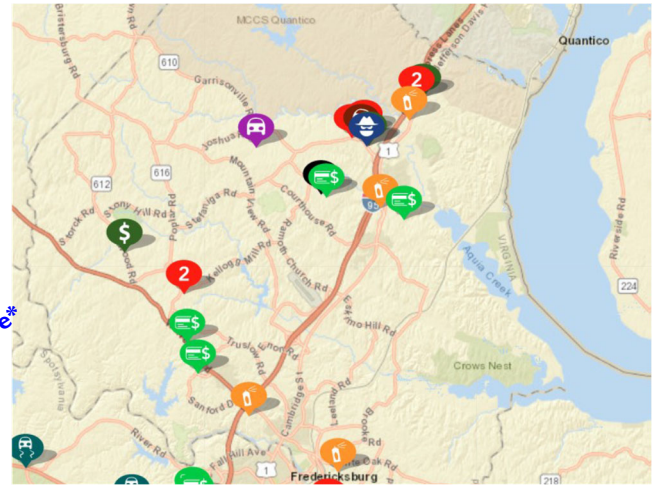

Suspect stated an error was made and a deposit of \$2,499.00 was credited to victim's personal bank account. Victim was instructed to purchase four (4) \$500 gift cards and provide suspect with the numbers. Victim became suspicious and ended the call, contacted bank and cancelled accounts; no monetary loss to victim.**

Farragut Drive Aquia Harbour 05/06/21  
Larceny: Theft of firearm from unsecure vehicle.

## DELTA ZONE:

September Lane Autumn Ridge 05/04/21  
Fraud: Victim's identity compromised and Unemployment claim filed; no monetary loss.

Zoe Way Shelton Knolls 05/04/21
