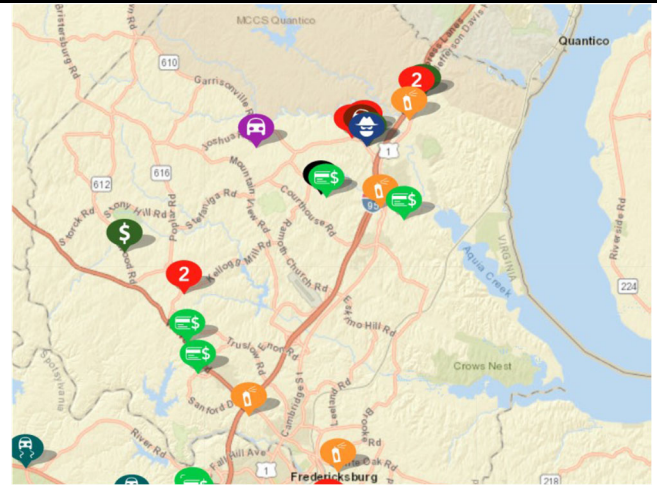

## BRAVO ZONE cont.:

Ponderosa Place Deacon Woods 05/12/23  
Fraud: SCAM: Victim paid \$300 for tickets they found on the Facebook reseller group. Victim paid for the tickets via CashApp, but never received the tickets or link as promised. Monetary loss of \$300.

Chatham Street 05/12/23  
Fraud: SCAM: Victim befriended an individual through an online dating app. After several months of correspondence, the "new friend" began asking for financial assistance; victim sent money. After several months of asking for the borrowed funds of \$1,200 to be repaid, victim received a check in the amount of \$11,200. Victim attempted to deposit the check but their bank informed them the check was fraudulent. It was at this time, the victim realized they had been scammed from the beginning. Monetary loss of \$1,200.

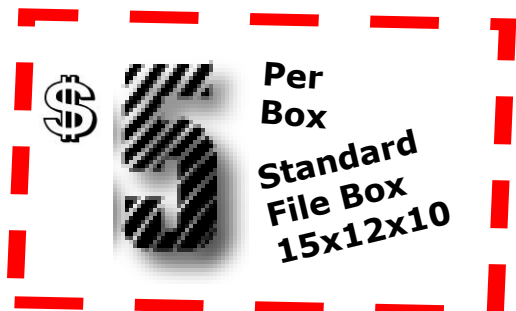

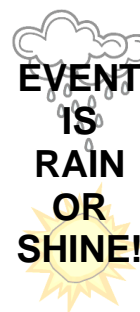

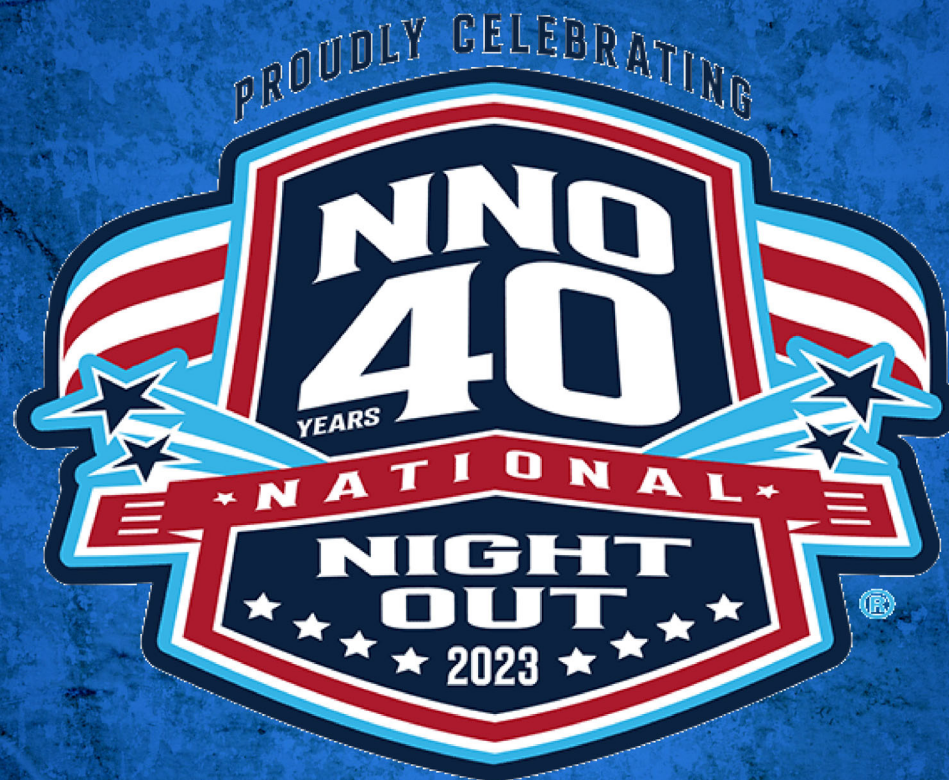
