

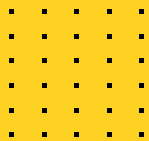

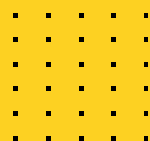
WEEKLY CRIME REPORT



NOVEMBER 11TH – NOVEMBER 17TH, 2024



ALPHA ZONE



LARCENY

Autumn Drive. A deputy responded to a larceny. The victim advised his ex-girlfriend stole over \$1,000 worth of items following their breakup. The investigation is ongoing.

ABC, 9 Village Center Drive, a deputy responded to a larceny. Staff advised a male suspect stole a bottle of Anejo the day prior without staff knowing. After successfully committing shoplifting, the suspect returned this time to steal a bottle of Don Julio. The suspect was found and identified after robbing several businesses in nearby jurisdictions. Two (2) warrants for larceny were obtained and served on top of his other offenses.

Harmony at Falls Run. A deputy responded to a larceny. The victim exited the establishment to discover his Nissan Murano was no longer there. The investigation is ongoing.

ASSAULT

Amazon, 220 Centreport Parkway, a deputy responded to an assault. It was discovered there was a road rage incident between a Chevy and Nissan traveling on Centreport Parkway. The road rage escalated into an auto accident when the occupants of the Chevy involved assaulted the Nissan driver. Both occupants were charged with assault and battery, assault by mob, and disorderly conduct.

Taylors Hill Way. A deputy responded to an assault. A juvenile was assaulted after an exchange of words with another juvenile. A criminal complaint for assault and battery was submitted.

INDECENT EXPOSURE

Green Tree Road. A deputy responded to an indecent exposure report. The victim advised a male was peeping in her window. When she went outside to walk her dog, she saw everything the male wasn't wearing. The deputy identified the naked nuisance and he was charged with peeping and indecent exposure.

DUI

Area of Poplar Road and Truslow Road. A deputy was traveling in the area when he observed a driver who, unfortunately, ran out of gas. Her bad luck continued when the deputy noticed signs of intoxication. The driver admitted to consuming "a little bit" of alcohol prior to driving. An open can of sparkling wine was also located within the vehicle. She was charged with driving under the influence and drinking while driving.

PUBLIC INTOXICATION

Sleep Inn, 595 Warrenton Road. A deputy responded to a disturbance. Staff advised a loud female was causing a scene. The deputy made contact with the suspect who provided a hard to understand story involving a teddy bear magically appearing in her room. During their interaction, the deputy would observe signs of intoxication. The suspect also began yelling at a bystander and causing a bigger scene. She was arrested for public intoxication.

BRAVO ZONE

LARCENY

Duff McDuff Park. Deputies responded to two (2) larceny reports. Victim #1 had her purse stolen from her unlocked vehicle while victim #2 had a window of her vehicle smashed and her purse stolen.



CHARLIE ZONE

PUBLIC INTOXICATION

Lusitania Drive. A deputy responded to an unknown problem. An individual called dispatch, but would not respond to dispatchers. When the deputy arrived, he made contact with a female, who was under the influence and was charged with public intoxication.

ASSAULT

Cavalier Skating Center. A deputy responded to an assault. The suspect misplaced his AirPods and blamed the victim for stealing them. The suspect forcibly searched the victim before assaulting him. The suspect was charged with assault and battery. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

Rappahannock Regional Jail. A deputy was assisting in processing a suspect at the jail for a domestic incident. The suspect, unhappy about the situation he created, made things worse when he kicked off one of his crocs and it struck a jail officer. He was charged with assault and battery of a jail officer and was held without bond.

LARCENY

Paradise Court. A deputy responded to a larceny. The victim's vehicle, a 2015 Dodge Charger, was stolen. The investigation is ongoing.

DISTURBANCE

Davenport Drive. A deputy responded to a disturbance. It was discovered a family member got upset over finding out who ate all the Doritos. This would escalate to a verbal argument that deputies intervened in just prior to an assault occurring. The suspect would continue her yelling spree and disregard deputies' commands. When deputies attempted to detain her, she resisted. She was charged with disorderly conduct and obstruction of justice.



DELTA ZONE

ASSAULT

Catherine Lane. A deputy responded to an assault. The caller advised her boyfriend was just assaulted by his ex-girlfriend. It was discovered the ex-girlfriend responded to the residence and assaulted the victim over a cellphone. The ex-girlfriend was located and served on a warrant for assault and battery.

AG Wright Middle School. A deputy was conducting her SRO duties when she was informed of an assault. Two (2) students were exchanging words and about to fight when a third student attempted to separate them and de-escalate the situation. Instead of fighting each other, the first two students began assaulting the third student. Criminal complaints for assault and battery were filed on the first two students.

LARCENY

Onelife Fitness, 315 Garrisonville Road. A deputy responded to a larceny. While the victim was pumping some iron, his wallet was stolen from the locker room.

Home Depot, 305 Worth Avenue. A deputy responded to a failed shoplifting. Staff advised a male and female attempted to remove the Spider Wrap anti-theft device from multiple items. When the devices did what they were designed for and created an alarm, staff went to confront the pair. The pair would quickly flee the scene. The deputy was able to identify the male suspect and obtain warrants for him; however, the female is still unknown.

Onelife Fitness, 315 Garrisonville Road. A deputy responded to a larceny. The victim advised while working out, her wedding ring accidentally came off and was taken.

PUBLIC INTOXICATION

Wawa, 105 Garrisonville Road. A deputy responded to a public intoxication report. The caller advised a drunk male was knocking on the doors of businesses. The deputy observed the mud-covered suspect as he stumbled into the Wawa. The suspect had instantly noticeable signs of intoxication and was rather disorderly during his conversation with deputies. He was charged with public intoxication.

DRUGS

North Stafford High School. A deputy was conducting his SRO duties when he was informed of drug activity. Instead of packing lunch, a student packed a THC vape. The vape was collected and a criminal complaint for underage possession was submitted.

DUI

Area of Garrisonville Road and Onville Road. A deputy responded to a driver under the influence report. The caller advised a work van was traveling well beneath the speed limit, entered into oncoming traffic, and had the strong odor of a controlled substance emitting from the vehicle. The deputy would observe the van swerving and conducted a traffic stop. As soon as the driver rolled down his window, the deputy was struck with the heavy odor of a freshly burnt controlled substance. The driver had signs of intoxication and admitted to smoking a leafy controlled substance. The driver was charged with driving under the influence and held at Rappahannock Regional Jail on a \$5,000 secured bond.

SCAM-AWARE

Victim received a call from a female named Maria Gonzalez. Maria claimed to be from Customs and Border Patrol. She advised that the victim had accounts in El Paso, Texas and those accounts were consistent with money laundering. Maria then transferred the victim to her alleged supervisor, Clara Hobbon, who stated the same thing. They advised that the U.S. Marshals would be in contact with him about a court date and possible litigation. The victim was then contacted by the US Marshalls again and advised that they were going to assign the victim a new Social Security Number, but they needed to confirm his identity first. In order to confirm his identity, he had to verify his assets by withdrawing as much money as he could and place it into a Bitcoin account. They advised if he did not do this, they were going to proceed with the money laundering charges and there will be a warrant for his arrest.

The victim proceeded to withdraw \$20,000. While on the way to place the funds into the Bitcoin machine, he told Shannon that he was not going to go through with the transaction. Shannon advised that he will contact the local Sheriff's Office to confirm the validity of the transaction. The victim then received a call from the Stafford County Sheriff's Office and they reassured that what Shannon was saying was correct. The victim completed the transaction and placed \$20,000 into the Bitcoin machine.

The victim was instructed to withdraw an additional \$10,000, and proceeded to follow their instructions, however, became suspicious drove directly to the Sheriff's Office to report the scam.

Victim received a text message claiming to be his pastor and asked for him to buy eBay or Apple gift cards totaling to the amount of \$600 USD. The text message also claimed these gift cards would be used for kids at the hospital who had cancer. The victim would purchase the requested gift cards and provide the barcode of the gift cards to the via text. Shortly after, the victim received a group text message from his church stating that the pastor's identity was being used to deceive others into buying gift cards and warned to not reply to the impersonators.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest.
