

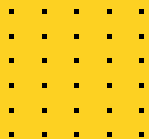

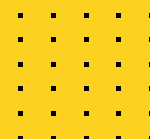
## **WEEKLY CRIME REPORT**

# ALPHA ZONE



## **HIT AND RUN**

Intersection of Warrenton Road and Sanford Drive. A deputy responded to a hit and run. While waiting for the light to turn green, the 1st victim's vehicle was rear-ended. This would cause a chain reaction and the 1st victim's vehicle would rear-end the 2nd victim's vehicle. The at-fault driver would quickly accelerate away. The suspect vehicle was described as a black and silver Ford F-150 with dual-rear exhaust pipes and is expected to have front-end damage.

## **LARCENY**

Walmart, 11 Village Parkway. A deputy responded to a larceny. Staff advised a female suspect was concealing items. After passing all points of sales with over \$800 worth of unpaid items, the deputy would make contact with the repeat shoplifter, who advised she "didn't see this as a problem." It was explained that "breaking the law" is in fact "a problem."

## **WARRANT SERVED**

Brenton Road. A deputy responded to a residential alarm. While it was a false alarm and the individual within the residence had permission to be in the home, it was discovered he was wanted out of Maryland. The suspect was charged with fugitive from justice.

## **ASSAULT**

Dollar Tree, 1095 International Parkway. A deputy responded to an assault. It was advised one male assaulted another after allegations of line cutting. The suspect would jump the line to see the magistrate, for he was charged with assault and battery.

## **PUBLIC INTOXICATION**

Days Inn. A deputy responded to a disturbance. It was advised an intoxicated female was yelling and banging on a motel door. The deputy made contact with the suspect, who was indeed intoxicated. Within her bag, a cocktail mix was located. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **THREATS**

Rollingside Drive. A deputy responded to a threats report. The victim advised a known male sent her threatening texts and voicemails due to him being incarcerated for a previous threats report. The deputy confirmed the suspect's identity and located him. The suspect was charged with felony threats to kill and using profane threatening language over the airways. He was held at Rappahannock Regional Jail without bond.

# BRAVO ZONE

## **ASSAULT**

YMCA. A deputy responded to a fight in progress. It was advised two (2) females were fighting in the parking lot. The deputy made contact with both parties and discovered the friends got into a disagreement over personal belongings. The situation between "frenemies" escalated when the suspect assaulted the victim. The suspect was charged with assault and battery.

## **PUBLIC INTOXICATION**

Ferry Road. A deputy responded to a disturbance. The caller advised people have been chasing him for "two days straight." The deputy made contact with the on-the-run individual, who advised "they" were watching and chasing him. The deputy, a Drug Recognition Expert, knew the signs the suspect was displaying were indicative of being under the influence. The suspect would also admit to consuming both alcohol and a controlled substance earlier. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **VANDALISM**

Ridge Point Subdivision. Deputies responded to a pumpkin-chunkin incident. The victim advised his vehicle had a side view mirror damaged. The only evidence left on scene was pumpkin guts. Deputies canvassed the area and located several additional smashed pumpkins, two (2) of which destroyed two (2) mailboxes. The great pumpkin assassin is still unknown.

Riggs Road. A deputy responded to a vandalism. The victim advised a known male refused to return her phone, but when he eventually did, it was broken. The deputy observed the damaged phone and made contact with the suspect. The suspect admitted to throwing the phone down because he was "real irritated." His irritated tyranny would earn him a warrant for felony destruction of property.

## **HIT AND RUN**

300 block of White Oak Road. A deputy responded to a hit and run. The victim advised he was traveling northbound on White Oak Road on his electric bicycle when he was struck by a black sedan. The suspect vehicle would flee onto Greenway Street. The area was canvassed and deputies located a black sedan with damage and paint transfer consistent with the crash. The driver advised he was not aware that he hit someone, but was willing to take responsibility. A warrant for misdemeanor hit and run was obtained. The victim only received minor injuries.

# CHARLIE ZONE

## **ASSAULT**

Brooke Point High School. A deputy was conducting his SRO duties when he heard a fight. Two (2) students decided to kick their Monday off by participating in a fight. Another student was able to break up the fight; however, only momentarily, the two students had reengaged in round two. Both received a criminal complaint for assault and battery.

## **PURSUIT**

Area of Richmond Highway and Potomac Creek Drive. A deputy was in the area when he observed Virginia State Police in an active pursuit. Without hesitation, deputies responded to assist in the pursuit. With their assistance, and a civilian driver, a modified rolling road block was conducted to stop the fleeing SUV. The driver was taken into custody by Virginia State Police.

## **WEAPON OFFENSE**

White Pine Circle. A deputy responded to a shooting into a dwelling report. The victim advised he heard a "pop" and noticed a hole in his ceiling. The bullet was located in the victim's kitchen. Following the bullet's path, deputies went to the apartment above and made contact with an occupant. While conversing with that individual, deputies noticed a bullet hole in his ceiling too. Again, deputies traveled upstairs and made contact with the occupant in the apartment above. He advised his firearm went off after it fell out of his pants. A warrant for reckless handling of a firearm was obtained.

## **DRUGS**

Stafford County Courthouse. A deputy was conducting her court duties when she was informed of drug activity. A jail officer observed an inmate in possession of suspected controlled substances. A warrant for possession of controlled substances was obtained.

Brooke Point High School. A deputy was continuing his SRO duties when he was informed of drug activity. Staff observed a female student vaping. The student would attempt to hide the vape in a feminine product and give it to another student. Her plan failed and the THC vape was collected. Criminal complaints for underage possession and possession on school grounds were submitted.

## **WEAPON OFFENSE**

Rappahannock Regional Jail. A deputy responded to a weapon offense. Jail staff discovered an inmate in possession of two (2) different makeshift knives. His cunning cutters were seized and a warrant was obtained.



# DELTA ZONE

## **LARCENY**

Walmart, 217 Garrisonville Road. A deputy responded to a larceny. Staff advised they were watching a female suspect skip-scanning items at the self-checkout register. The deputy made contact with the suspect who had nearly \$70 worth of stolen items consisting of crab dip and alcoholic beverages. The makings of a good snack night were returned to the business as the suspect was issued a summons for shoplifting.

Garfield Street. A deputy responded to a larceny. The victim had three (3) vehicles rifled through. During the suspect's hunt within the vehicle they were able to steal multiple items including a computer, a wallet, and money.

Lux Nails and Wax, 1630 Publix Way. A deputy responded to a larceny. Staff advised a female suspect, sporting a Chicago Bulls top, walked out without paying for her manicure. While taking the report, the suspect would call the business and begin cursing at staff about the quality of her "free" manicure. Thanks to camera footage, and caller ID, the deputy was able to identify the suspect. A warrant for larceny was obtained.

Publix. A deputy responded to a larceny. The victim advised she accidentally left her purse in her cart after shopping. When she returned, the purse was gone. With the help of the stores cameras it was discovered a male stole the purse while also shoplifting from the business.

## **DUI**

Sam's Pizza, 432 Garrisonville Road. A deputy was traveling in the area when he observed the driver in front of him straddling the white center line, essentially traveling in the middle of two lanes. The deputy conducted a traffic stop and made contact with the driver, who had signs of intoxication. While the driver admitted to consuming "one beer," his BAC would state otherwise. The driver was charged with driving under the influence with a blood alcohol content above .2.

Intersection of Mine Road and Courthouse Road. A deputy responded to a single-vehicle auto accident. It was advised the driver of a Honda was traveling on Mine Road when it continued straight through the intersection and collided with a one-way sign. The driver, who had signs of intoxication, advised he was heading to Massachusetts. He also advised that "Lemon says hi" and attempted to get the deputy to sing with him. The musical duet would need to wait; the driver was charged with driving under the influence. He was held at Rappahannock Regional Jail pending his ability to participate in a bond hearing.

## **WARRANT SERVED**

Probation & Parole Office, 85 Mine Road. Deputies responded to a warrant service. Staff advised an individual was there who was wanted for a felony probation violation. When deputies arrived, the suspect attempted to leave and refused commands. The suspect began to resist, and with the assistance of staff, the suspect was detained. The suspect was charged with obstruction of justice with force, as well as, served on their outstanding warrant.

# SCAM-AWARE

**Victim** received a call from the “Navy Federal’s Fraud Department.” The caller informed the victim that he needed to move his money to prevent him from being a victim of fraud. The victim was instructed to transfer \$1400 from his Navy Federal checking account to a partner bank virtual card, “GO2bank” on a virtual card specifically; victim complied.

The victim was then instructed to transfer an additional \$1500 from his Navy Federal credit card using the same process but a different bank; again, victim complied.

The suspect instructed the victim “wait on the line” to confirm the transactions had been completed, and as soon transactions were confirmed, the suspect disconnected from the victim. Victim immediately became skeptical of the situation and called Navy Federal. Navy Federal advised that they did not call him and this had been a scam.

**Victim** advised he received an email from someone posing as the Stafford County Sheriff’s Office. The fake Sheriff’s Office advised the victim that he missed court and needed to pay a “voucher” or face consequences.
