WEEKLY CRIME REPORT



NOVEMBER 25TH - DECEMBER 1ST, 2024

ALPHA ZONE

LARCENY

Wawa, 830 Warrenton Road. Deputies responded to a larceny. Staff advised a "repeat shoplifter" returned to shoplift again. Deputies located the suspect nearby and detained him without incident. The \$20 worth of snacks was returned to the business and the suspect was charged with shoplifting.

Walmart, 11 Village Parkway. A deputy responded to a larceny. Staff advised a female suspect was neglecting to scan certain items in her cart. The "nearly" \$140 worth of items were recovered and the suspect received a summons for shoplifting.

Walmart, 11 Village Parkway. Deputies responded to another Walmart larceny. Staff advised a female suspect passed all points of sale with approximately \$135 worth of items. The deputy made contact with the suspect and charged her with shoplifting. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.

Walmart, 11 Village Parkway. A deputy responded to a larceny. Staff advised a known shoplifter was back and currently concealing items. When staff attempted to stop the suspect, he fled on foot. The deputy was able to locate the suspect at a nearby business. The suspect had signs of intoxication and was currently drinking a club cocktail. The suspect was charged with larceny, shoplifting, and public intoxication. He was held at Rappahannock Regional Jail until sober.

PUBLIC INTOXICATION

Motel 6, 401 Warrenton Road. A deputy responded to a disturbance. The caller advised an exboyfriend showed up out of the blue and was "high on meth." The deputy made contact with the suspect, who was in view of the public, and observed several signs of intoxication. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

DISTURBANCE

Cropp Road. A deputy responded to a disturbance. The victim advised an ex-girlfriend egged his door. She would then take a screwdriver to the doorknob to force herself into his property. While attempting to have her leave, the suspect assaulted the victim. The suspect was charged with assault and battery, unlawful entry, and two (2) counts of destruction of property.

DUI

Area of Countryside Drive and Stony Hill Road. A deputy responded to a single-vehicle auto accident. A truck had serious damage, including three of the four tires being off the vehicle. Witnesses advised the driver stumbled off after the accident. The deputy located the driver nearby and made contact with him. The driver had severe signs of intoxication and informed the deputy that the auto accident was "none of your business." Due to his level of intoxication and agitated state, deputies attempted to detain him as he resisted. The driver would continue to act belligerent after being detained, threatening to kill deputies. Within the vehicle, deputies located an open beer container. He was charged with driving under the influence 2nd offense within 5 years, 2nd offense refusal, drinking while driving, two (2) counts of obstruction of justice, as well as, the traffic lane violation. He was held at Rappahannock Regional Jail pending his ability to participate in a bond hearing.

BRAVO ZONE

ASSAULT

Pecan Lane. A deputy responded to an assault. It was discovered that roommates got into a verbal argument. When a known male to the roommates attempted to de-escalate the situation, the suspect assaulted him. The suspect was charged with assault and battery.

McDonald's, 419 Chatham Heights Road. A deputy responded to a poultry problem. Staff advised a male suspect was not "lovin' it" when the chicken nuggets he ordered were not up to his five-star standards. Despite staff offering to remake his nuggets, he would instead launch his nuggets at staff.

DUI

Area of Cambridge Street and Manning Drive. A deputy was traveling in the area when she observed a Hyundai having a hard time maintaining the lane of travel despite going approximately 20 MPH. The deputy conducted a traffic stop and the driver had signs of intoxication and admitted to consuming "a few beers." Deputies observed numerous open Bud Light bottles strewn throughout the vehicle. The driver, currently on vacation, would have an extended layover for he was charged with driving under the influence, drinking while driving, driving without a license, as well as a traffic lane violation. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

PUBLIC INTOXICATION

Jan Drive. A deputy responded to a disturbance. The caller advised a known male was outside the residence knocking on doors and windows. The deputy made contact with the suspect, who had signs of intoxication and admitted to having "a couple" of shots throughout the day. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

RECOVERED STOLEN VEHICLE

Murphy Express, 450 Kings Highway. A deputy was traveling in the area when she observed a vehicle that had been reported stolen out of Fredericksburg. A high-risk stop was conducted and the driver was detained. The driver was issued a summons for driving while revoked. The Fredericksburg Police Department is handling the charges related to the stolen vehicle.

CHARLIE ZONE

DUI

Cavalier Skating Center. A deputy responded to a drunk driver complaint. The caller advised the driver of a Cadillac, who appeared to be "tweaking out," got out of his vehicle and began assaulting his bumper. The deputy made contact with the driver who had signs of intoxication and admitted to consuming alcohol before driving to this location. Using business cameras, the deputy confirmed the driver had driven to this location. He was charged with driving under the influence with a blood alcohol content between .15 and .2.

LARCENY

Maryanne Avenue. A deputy responded to a larceny. The victim had a blender delivered to her residence. When she went to retrieve it, it was nowhere to be found.

PUBLIC INTOXICATION

Pillar Church. A deputy was in the area for a domestic report when he observed a female suspect stumbling around. The deputy made contact with her and noticed several signs of intoxication. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Sheetz, 15 Wyche Road. A deputy responded to a public intoxication report. The caller advised a male was stumbling around the gas station. The deputy made contact with the suspect, who not only had signs of intoxication but was wanted out of Maryland. He was charged with public intoxication and fugitive from justice. He was held at Rappahannock Regional Jail without bond.

TRESPASS

7-Eleven, 3623 Richmond Highway. A deputy responded to a trespassing. Staff advised a suspect, who had been previously trespassed, was at the business again. The suspect would also curse at staff and use racial slurs towards them. The deputy made contact with the suspect and detained him without incident. He was charged with trespassing and using abusive language. He was held at Rappahannock Regional Jail without bond.

DELTA ZONE

DUI

700 block of Garrisonville Road. A deputy was traveling in the area when he observed an Alfa Romeo traveling 70 MPH in a 40 MPH zone. The deputy conducted a traffic stop on the Italian luxury vehicle and made contact with the driver, noticing signs of intoxication. The driver admitted to consuming "two Stellas" at a birthday party. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, as well as, reckless driving. He was held at Rappahannock Regional Jail without bond.

Area of Courthouse Road and Monument Drive. A deputy was traveling on Ramoth Church Road when the vehicle behind him had their high beams on and veered over the double yellow line. The deputy pulled behind the vehicle and conducted a traffic stop. The driver had signs of intoxication and at first advised he did not consume any alcohol and to "trust me." His answer later changed and he confirmed he consumed alcohol before getting behind the wheel. The driver was charged with driving under the influence and the traffic lane violation. He was held at Rappahannock Regional Jail until sober.

PUBLIC INTOXICATION

Wawa, 920 Wonder Road. A deputy responded to an intoxicated person report. The caller advised an obviously intoxicated male was asking employees where he could get a good deal on meth. The deputy made contact with the meth inquirer and noticed signs of intoxication. The suspect, now unhappy about being arrested, became irate and began shouting at the deputy. The suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Select Leaf Tobacco, 261 Garrisonville Road. A deputy responded to an intoxicated person report. The caller advised a male was stumbling around and appeared intoxicated. The deputy made contact with the stumbling suspect and noticed signs of intoxication. The suspect also admitted to consuming "a couple shots." He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

THREATS

Colonial Forge High School. A deputy was conducting her SRO duties when she was informed of a threat. A student sent threatening text messages to another student due to a disagreement over a boy. A criminal complaint for using threatening language was filed.

SCAM-AWARE

Victim was on his computer attempting to log in to his investment account selecting a link that he thought was the legitimate website for the Schwab account. When he attempted to gain access to his account a pop-up appeared on his screen and advised that there was an account error and he needed to contact the phone number on the screen. He called the phone number and spoke with "David" who was an IT specialist for Schwab. "David" advised the victim that his account had been compromised and an individual had put in an order for \$14,000.00 with Bitcoin. The victim was instructed to take out \$14,000.00 in cash and deposit it into a Bitcoin machine to start a new transaction for Bitcoin. This new transaction would then help "David" cancel the false charge; the victim complied. The victim was told he would be contacted by noon to confirm the new account had been established. By noon the following day, the victim had not received a call and realized he had been the victim of a scam.

Victim advised he received a message on his computer about an error with his investment account. Using the phone number provided in the message, the victim made contact with an individual who advised the victim needed to transfer money into Bitcoin to cancel the error. Victim knew this was a scam and disconnected.

Victim advised he received a call from someone posing as a law enforcement officer. The fake officer informed the victim he had missed court in Alexandria and needed to pay using cryptocurrency to avoid being arrested. Victim disconnected immediately.
