

## WEEKLY CRIME REPORT



**NOVEMBER 4TH - NOVEMBER 10TH, 2024** 

### **ALPHA ZONE**

#### DUI

Plantation Drive. A deputy conducted a traffic stop on a Toyota for a traffic lane violation. The driver had strong signs of intoxication, admitted to consuming two (2) beers, but despite that, advised "I feel like I'm good." When it was discovered he was not as "good" as he thought, the driver's behavior became less than pleasant with deputies. Despite openly admitting to consuming alcohol before driving, he believed it did not constitute an arrest and the incident was "bull." The driver was charged with driving under the influence, refusal, and the traffic lane violation.

Motel 6, 401 Warrenton Road. Deputies responded to a drunk driver complaint. The caller advised a van was swerving and nearly struck multiple vehicles before parking at the Motel 6. The caller further advised the driver exited his vehicle, went into a nearby market, and returned to the vehicle with a case of beer. Deputies easily located the work van and made contact with the driver when the driver quickly threw his vehicle into reverse. Luckily, a deputy had positioned his cruiser behind the van to prevent it from leaving. The driver had signs of intoxication, admitted to consuming approximately six (6) beers, in addition to one of the beers he just bought; a Modelo was sitting in the center console. He was charged with driving under the influence with a blood alcohol content between .15 and .2.

Area of Warrenton Road and Melchers Drive. A deputy made contact with a driver of a Nissan Altima on the side of the road when he observed a bottle of Don Julio in plain view. The driver had signs of intoxication, admitted to consuming "about two shots," and was in possession of a firearm. He was charged with driving under the influence and carrying a firearm while intoxicated.

700 block of Truslow Road. A deputy responded to a single-vehicle auto accident. A Toyota was totaled after leaving the roadway and striking a rocky embankment. The driver, who somehow avoided injury, had signs of intoxication and admitted to consuming a vodka cranberry. The driver was charged with driving under the influence.

#### SWATTING

Basalt Drive. A deputy responded to a shooting of a person report. The caller advised he just shot a family member and threatened to shoot himself. As the call continued, dispatch detected indicators of swatting. The deputy made contact with the occupants of the address and discovered no such emergency had occurred.

#### TRESPASS

Truckin Thunder, 6 Commerce Parkway. Deputies responded to a trespassing. Staff advised a vagrant, who was trespassed from the business on Halloween, was back again. Deputies made contact with the suspect who demanded that law enforcement should be called. She was informed that deputies are in fact law enforcement and deputies attempted to detain her when she began to resist. She was eventually placed in handcuffs and charged with trespassing and obstruction of justice. She was held on a \$500 secured bond.

#### FRAUD

Lendall Lane. A deputy responded to a fraud. Someone in Florida would be gaining a Ninja mixer after fraudulently using the victim's information.

#### **BREAKING AND ENTERING**

Overlook Court. Deputies responded to a breaking and entering. The caller advised a sliding door was removed from the doorframe and they could hear voices coming from the inside the residence. Deputies cleared the residence and located an 18-year-old and juvenile inside. The suspects admitted to unlawfully entering the property and were "just chillin". The 18-year-old was issued summonses for unlawful entry and contributing to the delinquency of a minor. A criminal complaint for unlawful entry was submitted for the juvenile.

#### DUI

Area of Primmer House Road and Morton Road. A deputy observed a Ford failing to maintain the lane of travel and conducted a traffic stop. The driver had signs of intoxication and admitted to consuming a vinegar and wine mix. Within her vehicle was not only half of her questionable cocktail of choice with open bottles of wine, but a loaded firearm hidden from view. She was charged with driving under the influence, carrying a concealed weapon, and refusal. She was held at Rappahannock Regional Jail on a \$,2500 secured bond.

#### ASSAULT

Rappahannock Regional Jail. A deputy responded to an assault. It was discovered one inmate assaulted another over a disagreement on a deck of cards. This full-house incident ended with the predominant aggressor being charged with assault and battery.

#### LARCENY

Enterprise Car Rental, 2875 Richmond Highway. Deputy responded to a larceny. Staff advised a Nissan Armada was supposed to be returned by the renter during October, yet the business had yet to receive it.

#### DUI

1800 block of Richmond Highway. A deputy located a DUI driver. While traveling Northbound, the deputy observed a van impeding traffic with his extremely low speed while in the left lane. The deputy conducted a traffic stop and made contact with the driver. The driver blamed his less than ideal driving on his GPS; however, the signs of intoxication and open container of alcohol led the deputy to think otherwise. After field sobriety tests, the driver was charged with driving under the influence, drinking while driving, and impeding the flow of traffic.

Sheetz, 15 Wyche Road. A deputy was traveling Northbound on I-95 when he observed a Hyundai traveling 47 MPH. Despite the low speeds, the driver was having a hard time not swerving on the roadway and would travel without headlights. The deputy conducted a traffic stop and found the driver had signs of intoxication, admitted to consuming a mixed drink, and was in possession of a firearm that was concealed from view. He was charged with driving under the influence, carrying a concealed weapon, the traffic lane violation, and driving without headlights. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Belle Plains Road. A deputy responded to a single-vehicle auto accident. The caller advised a Mustang was in a ditch and the driver appeared intoxicated. A deputy made contact with the driver, who advised he backed up too far and ended up in this predicament. The driver had signs of intoxication and admitted to consuming "a little bit" of alcohol. That "little bit" was determined to be a "big bit" for he was charged with driving under the influence with a blood alcohol content above .2.

#### LARCENY

Colonial Forge High School, 550 Courthouse Road. A deputy responded to a larceny report. A student advised his phone and Air Pods were stolen the day before from the boy's locker room. The investigation is ongoing.

Home Depot, 305 Worth Avenue. A deputy responded to a larceny. Staff advised they noticed a female suspect checking out items where the price did not match the items in question. It was discovered the suspect switched price tags in an attempt to pay a lower price. The \$150 worth of items were recovered and the suspect was issued a summons for shoplifting.

Home Depot, 305 Worth Avenue. A deputy responded to a box of tricks report. Staff advised a male returned a tool set and received money back for it. Unfortunately, when staff unboxed the container and discovered it to be filled with nothing but bricks, the suspect was already gone.

#### **PUBLIC INTOXICATION**

Minuteman Circle. A deputy responded to a disturbance. The caller advised he was an "angry drunk" and wanted to hurt someone. The deputy made contact with the caller and observed signs of intoxication. He was charged with public intoxication.

Travis Lane. A deputy responded to an unknown problem. The caller advised there was a female sitting in the middle of the road. The deputy located the suspect still sitting in the road as she displayed signs of intoxication. The suspect admitted to consuming multiple mixed drinks before arriving at this location. She was charged with public intoxication.

#### DUI

Buffalo Mo's. A deputy observed a Hyundai make an illegal left turn from Garrisonville Road to Salisbury Drive. The poor driving behavior continued as the driver was having a hard time maintaining the lane of travel. The deputy conducted a traffic stop and made contact with the driver, who had signs of intoxication. The driver must have had the munchies, for he advised he just came from McDonald's, yet his GPS was taking him to a local Wendy's. The driver's destination was recalculated to Rappahannock Regional Jail where he was charged with driving under the influence, refusal, and two (2) counts of traffic lane violations.

Intersection of Garrisonville Road and Mine Road. Deputies responded to an unknown problem. The caller advised a Nissan had been sitting at the traffic light through multiple light cycles. Deputies observed the Nissan driver had fallen asleep with his foot on the brake. After his wakeup call, stronger than your common expresso, deputies observed several signs of intoxication. The driver would also admit to consuming two (2) margaritas before deciding to drive. The margarita lover would tango down to Rappahannock Regional Jail where he was charged with driving under the influence.

Orville Road. A deputy was traveling on Garrisonville Road when he observed a speeding Nissan. The Nissan driver would put his left turn signal on and proceed to turn right, cutting off two (2) vehicles in the process. The deputy conducted a traffic stop and observed signs of intoxication. After conducting field sobriety tests the driver was charged with driving under the influence.

### **SCAM-AWARE**

**Victim** received a phone call from 800-837-4966. The number displayed on her phone as "Verizon Support". The caller asked if she had requested her number to be ported from Verizon to T-Mobile. When the victim informed the caller that she had not made that request, the caller then stated he would have to send her a text message in order for her to allow him access to make the phone. The victim received a message from a short code number of "899000", which she stated was the same number from Verizon that notifies her of her payments and such. Shortly after the victim's iPhone 14 Pro Max went into SOS mode, and she was unable to access it. A short time later, the victim received a phone call from her financial institution informing the victim of fraudulent detection informing the victim that her account had been changed and a new credit card had been opened and had sustained \$4,623.72 of fraudulent charges.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest.
