BRAVO ZONE

LARCENY

Ferry Farm Repair. A deputy responded to a larceny. A catalytic converter was stolen from a Ford truck. Using business cameras, it was discovered that the larceny took place at approximately 4:27 a.m. that morning.

PUBLIC INTOXICATION

Sledgehammer Drive. Deputies responded to a public intoxication call. The caller advised there was an intoxicated male in the parking lot. When the deputy arrived, he instantly knew the suspect from prior encounters. The suspect had signs of intoxication and received a charge for public intoxication. He was held at Rappahannock Regional Jail until sober.

Sandy Ridge Road. A deputy responded to a suspicious person's call. The caller observed an unknown female at his front door using his Ring camera. The deputy made contact with the suspect, who had signs of intoxication. The suspect admitted to consuming alcoholic beverages at a residence nearby; however, she also believed she was in Caroline County. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

FOUND PROPERTY

Forbes Street. A deputy responded to the found property. The reporting party discovered a rifle and shotgun in the residence. The firearms were turned over to the deputy and an ATF trace form was submitted.

DUI

Area of Cherry Laurel Drive and Brentwood Lane. A deputy was in the area when he observed a Ford stopped at a stop sign. The deputy observed the unmoving driver for approximately two minutes before making contact with him. The driver had signs of intoxication and admitted to consuming "a lot" of alcohol. After field sobriety tests the driver was charged with driving under the influence and stopping in the roadway. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

Pegs Lane. A deputy responded to a disturbance. The caller advised that a known male, who was intoxicated, was inside her vehicle and refusing to exit. When the deputy arrived, the vehicle in question was gone. That being said, it would return shortly after and the driver would stumble out. The driver had signs of intoxication, no driver's license, demanded deputies to "take me" to jail, and while conversing with deputies, would produce not one (1), but three (3) Modelos from his jacket. The driver was charged with driving under the influence, driving without a license, and refusal.

CHARLIE ZONE

LARCENY

Tobacco Holy Pipe. A deputy responded to a larceny. Staff advised that a female suspect ran out of the business with \$45 worth of merchandise.

DUI

Intersection of Richmond Highway and Hospital Center Boulevard. A deputy was traveling in the area when he observed a vehicle traveling only 15 MPH. Despite the extremely slow speed on Richmond Highway, the driver was still having a hard time maintaining the lane of travel. At the intersection the driver would stop and fall asleep at the green light, making it easy for the deputy to conduct a traffic stop. The deputy observed a bottle of Maker's Mark in plain view and the driver had signs of intoxication, and after field sobriety tests were administered, he was detained. The driver was charged with driving under the influence, drinking while driving, refusal, and the traffic lane violation.

PUBLIC INTOXICATION

Area of Tracey Street and Draper Circle. A deputy responded to a public intoxication report. The caller advised there was a male in the area who was clearly intoxicated. The deputy made contact with the suspect and came to the same conclusion; he was clearly intoxicated. The suspect advised he consumed four (4) beers. He was charged with public intoxication.

DRUGS

Courtyard Marriott. A deputy responded to a disturbance. It was advised a male, who appeared to be "tweaking out," was acting erratically in the elevator. The erratic elevator rider was not located; however, a controlled substance was. After conversing with a witness, it was discovered the suspect left on foot before the deputies' arrival. Deputies walked along the path the suspect was seen leaving and located bags. Within the bags were additional suspected controlled substances, paraphernalia, and identifying information on the suspect. The investigation is ongoing.

HIT AND RUN

Hope Road. A deputy responded to a hit-and-run. A Jeep struck an unoccupied Honda. Using the items found within the Jeep, including the suspect's phone, the suspect was identified. Later in his shift, the deputy was able to locate the suspect at a nearby residence. He was charged with hit and run and held at Rappahannock Regional Jail on a \$3,000 secured bond.

VANDALISM

Courthouse Road Divergent Diamond. A deputy responded to a road rage incident. While traveling Eastbound, two (2) vehicles almost crashed into each other. In response, the suspect threw his McDonald's iced coffee at the victim's vehicle. In response to the unwanted coffee, the victim held up the middle finger. The suspect would then damage the victim's passenger side mirror. The suspect admitted that he "lost my cool." For losing his cool and his coffee, warrants for destruction of property and disorderly conduct were obtained.

Area of Richmond Highway and Town Center Boulevard. A deputy responded to a road rage incident. While traveling Northbound, the driver and passenger of a Toyota Camry were unhappy with the victim's driving and let it be known by honking at her. In response, the victim held up the middle finger. The passenger of the Camry would then throw a beverage at the victim's vehicle.

DELTA ZONE

LARCENY

7-Eleven, 378 Garrisonville Road. Deputies responded to a larceny. Staff advised a juvenile stuffed her pockets with sausages. The sausage stuffing suspect was issued a shoplifting summons.

Kohl's, 1220 Stafford Market Place. A deputy responded to a larceny in progress. Staff advised two (2) females just stole approximately \$165 worth of skin care items before fleeing on foot. The deputy located the suspects in a neighboring store with the stolen items still in their possession. Suspect #1 would provide a false identification while suspect #2 was smart enough not to do that. After the identity of suspect #1 was uncovered it was discovered both suspects were juveniles. Suspect #1 received criminal complaints for shoplifting, identity fraud, providing a false identity to law enforcement, and obstruction of justice. Suspect #2 received a criminal complaint for shoplifting.

Walmart, 217 Garrisonville Road. A deputy responded to a larceny. Staff advised two (2) males stole a cart full of items, valued at over \$1,400. The deputy was able to connect this larceny to similar ones in nearby jurisdictions. The investigation is ongoing.

DRUGS

Mountain View High School. A deputy was conducting his SRO duties when he was informed of drug activity. Someone forgot their THC vape in the boy's bathroom, and a staff member located it abandoned in the sink.

LARCENY

Staffordboro Commuter Lot. A deputy responded to a larceny. The victim advised numerous items were taken from his vehicle, including a laptop, rifle magazines, and backpack.

ASSAULT

Colonial Forge High School. A deputy was conducting his SRO duties when he was informed of an assault. It was discovered a student entered a classroom and kicked another student in the face. A criminal complaint for assault and battery was filed.





SCAM-AWARE



Victim was contacted by an unknown number on the WhatsApp. The person in the message asked him if he wanted to make easy money on Bitcoin. He advised he went back and forth with the person and was told to pay \$300 and promised it would double. The victim advised he transferred the money as the subject requested and never received anything in return. The victim said the subject kept asking for more money and by the time he caught on to the scam it was too late with a loss of \$2,747.
