WEEKLY CRIME REPORT



OCTOBER 7TH – OCTOBER 13TH, 2024

ALPHA ZONE

DUI

Area of Warrenton Road and Melchers Drive. A deputy responded to a disturbance. It was reported that an intoxicated driver was engaged in a verbal argument with his passenger. The driver ended the conversation by parking his vehicle in the roadway and walking away. The deputy located the driver and discovered he was in fact in an intoxicated state. The driver admitted to consuming "a couple of drinks" before getting behind the wheel. He was charged with driving under the influence, driving with a suspended license, stopping in the roadway, and refusal. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

CRIMINAL ACTIVITY

Target, 25 South Gateway Drive. A deputy responded to a peeping tom report. It was advised a juvenile victim was in the dressing room when an unknown male attempted to take pictures of her in a state of undress. When he was discovered, he fled the business. The suspect was described as a tall black male with short brown braids and a goatee.

LARCENY

Super 8, 557 Warrenton Road. A deputy was on scene for an unrelated matter when she observed a Mercedes. This Mercedes was discovered to be stolen out of New York. Using business cameras, the deputy discovered the suspect in possession of the stolen vehicle and made contact with her. The suspect advised she was "renting" it from a "friend," but that was discovered to not be the case. Within the vehicle were fake driver's licenses. She was charged with receiving stolen goods greater than \$1,000 and three (3) counts of possession of a fake driver's license. She was held at Rappahannock Regional Jail without bond.

Royal Farms, 4 Commerce Parkway. A deputy responded to a larceny. Staff advised a female suspect stole food and left in a silver Jeep. The deputy located the suspect vehicle on Spruce Lane and observed the described suspect involved. The suspect would provide a false identification in an attempt to avoid her outstanding Stafford County warrants. Her plan failed. Within the vehicle were the stolen food and suspected controlled substances. She was charged with shoplifting, possession of controlled substances, identity theft, and providing false identification to law enforcement. She was additionally served on her outstanding warrants and held at Rappahannock Regional Jail without bond.

THREATS

Robinson Lane, A deputy responded to a disturbance. It was discovered an ex-boyfriend sent threats of death to the reporting party's current boyfriend. A warrant for threats of death was submitted.

BRAVO ZONE

DUI

600 Block of Kings Highway. A deputy was traveling eastbound when he observed a vehicle having a hard time staying in its lane. The deputy conducted a traffic stop and made contact with the driver. The driver had signs of intoxication, admitted to consuming “maybe two drinks,” had two (2) empty alcoholic bottles within her vehicle, and had no driver’s license. At the Rappahannock Regional Jail Intake, a suspected controlled substance was located hidden within her wallet. She was charged with driving under the influence, possession of a controlled substance, driving without a license, and the traffic lane violation. She was held on a \$5,000 secured bond.

Dairy Queen, 207 Kings Highway. The deputy was traveling in the area when she observed a motorcycle traveling 68 MPH in a 45 MPH zone. The deputy conducted a traffic stop and made contact with the driver. The driver had signs of intoxication, admitted to consuming three (3) Michelob Ultras, and had difficulty finding his registration despite it being in his hand. The driver was charged with driving under the influence and reckless driving. He was held at Rappahannock Regional Jail until sober.



CHARLIE ZONE

ASSAULT

Brooke Point High School. The deputy was starting his day when he was informed of a fight in the girl's bathroom. It was discovered the victim and student one was engaged in a verbal disagreement over one of them bumping the other in the hallway. Student #1 would then assault the victim as student #2 jumped in to assist. This ruckus got staff's attention who attempted to break up the assault. During the incident, a staff member was assaulted. Both students received criminal complaints for assault and battery, as well as, assault and battery on school staff.

Courage Lane. A deputy responded to an assault. It was advised a female suspect assaulted the victim due to a previous eviction. The deputy located the suspect and detained her without incident. She was charged with assault and battery and held at Rappahannock Regional Jail without bond.

DUI

Area of Richmond Highway and Castle Court. A deputy responded to an auto accident. The victim was rear-ended while attempting to make a turn. The at-fault driver had signs of intoxication and admitted to consuming two (2) "Crown & Cokes" before getting behind the wheel. He was charged with driving under the influence and following too closely. He was held at Rappahannock Regional Jail on a \$1,000 secured bond.

Boswell's Corner. A deputy was traveling Northbound on Richmond Highway near Corporate Drive when he observed a vehicle traveling Southbound at 66 MPH in a 45 MPH zone. The deputy conducted a traffic stop and the 19-year-old driver had signs of intoxication but admitted to consuming "not much" alcohol. "Not much" apparently, is five (5) shots of Crown Royal for the underage driver. She was charged with driving under the influence, driving after illegally consuming alcohol and reckless driving. She was held at Rappahannock Regional Jail until sober.

Children's Hospital of Richmond, 2781 Richmond Highway. A deputy was in the area when he observed a running vehicle at the closed business. As the deputy approached the driver, he attempted to take off; however, he was quickly stopped. The driver had signs of intoxication and attempted to conceal a firearm under his leg. The driver was detained and admitted to scratching the serial number off of the firearm. He was charged with driving under the influence, possession of a concealed firearm while intoxicated, removing the serial number of a firearm, and driving without a license.

LARCENY

Castlebury Court. A deputy responded to a disappearing act. The victim advised one moment his Honda was there, and the next, poof, it was gone. The vehicle was entered as stolen into a law enforcement database. The next day, just as fast as the vehicle had disappeared, it magically reappeared and was no longer labeled as "stolen".

Oak Drive. A deputy responded to a vehicle larceny. The victim advised her vehicle was supposed to be towed to an auto shop; however, after contacting the auto shop they advised they did not have it; with her vehicle missing, it was entered as stolen into a law enforcement database.

VANDALISM

Raynar Court. A deputy responded to a vandalism. The victim advised his Ring camera had been damaged. The funny thing about doorbell cameras is they often record things, in this case, the vandalism was caught on camera. With the footage, a suspect was identified and a warrant for destruction of property will be obtained.

DELTA ZONE

ASSAULT

Colonial Forge High School. The deputy was conducting his SRO duties when he was informed of a fight. Two (2) students engaged in mutual combat when staff separated them. After they were separated, a 3rd student interjected herself and assaulted one of the students involved. The 3rd student received a criminal complaint for assault and battery. The two (2) students engaged in mutual combat were not charged.

North Stafford High School. The deputy was conducting her SRO duties when she heard a commotion coming from the boy's bathroom. It was discovered that student #1 and student #2 engaged in a fight. During the fight, a bathroom sink was detached from the wall and student #3 would interject himself in the fight. Student #1 and student #2 received criminal complaints for assault and battery, as well as, destruction of property. Student #3 received a criminal complaint for assault and battery.

Stafford Mews Lane. A deputy responded to a fight. It was advised a group of juveniles were actively fighting. It was discovered two (2) female juveniles engaged in a fight while the father of one of the juveniles encouraged the altercation. Both juveniles received a criminal complaint for assault and battery. Charges for contributing to the delinquency of a minor for the father are pending.

DUI

7-Eleven, 201 Garrisonville Road. Deputies responded to a drunk driver complaint. The caller advised they had been following a vehicle and the driver might be intoxicated. The caller further advised the suspect driver fell asleep behind the wheel at a green light and had to be forcibly awoken. Deputies observed the suspect vehicle in the 7-Eleven parking lot with the driver asleep and his foot on the brake. When the driver woke up, deputies noticed signs of intoxication. The driver admitted to consuming alcohol before driving; however, he assumed he could not be arrested since he was on private property. He was incorrect. The driver was charged with driving under the influence with a blood alcohol content greater than .2.

The intersection of Garrisonville Road and Salisbury Drive. A deputy observed a vehicle with jerky movements as it had a hard time maintaining the lane of travel. The deputy conducted a traffic stop and made contact with the driver. The driver had signs of intoxication, admitted to consuming six (6) beers before getting behind the wheel, and illegal window tint. He was charged with driving under the influence, refusal, a traffic lane violation, and excessive window tint. He was held at Rappahannock Regional Jail until sober.

Jeff Rouse Swim and Sports Center, 1600 Mine Road. A deputy responded to multiple vehicle break-ins. Three (3) vehicles had windows shattered and personal items, including credit cards, were stolen. The larcenies are under investigation.

DRUGS

Hickory Lane. Deputies responded to a 'suspicious person' call. The reporting party advised a male she knew from high school was randomly asleep in his vehicle in her driveway. Deputies made contact with the suspect, who they knew from prior incidents, and asked for consent to search the vehicle. The suspect advised there was nothing illegal within the vehicle and gave deputies consent to search the vehicle. Approximately ten seconds into the search, deputies located a suspected controlled substance. The suspect was detained as additional paraphernalia was located, as well as, ammunition. He was charged with possession of controlled substances, a felon in possession of ammunition, and possession of controlled paraphernalia. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.
