# WEEKLY CRIME REPORT

## **ALPHA ZONE**

#### **LARCENY**

Rivermont School - A school bus had its catalytic converter stolen.

Piney Hill Lane - The victim had a nail gun and firearm stolen from his vehicle

#### DUI

Holiday Inn, 20 Sanford Drive – A deputy was investigating a domestic-related incident when she observed a male driving in the parking lot. The deputy observed signs of intoxication coming from the driver. Within the vehicle were multiple open cans of beer. The driver was charged with driving under the influence and drinking while driving. He was held at Rappahannock Regional Jail on a secured bond.

Plantation Drive a deputy was traveling on Warrenton Road when he observed a vehicle run a red light. A traffic stop was conducted, and the driver had signs of intoxication, admitted to having "two beers," and an empty alcoholic can was located within the vehicle. The driver was charged with driving under the influence and failure to obey a traffic light. He was held at Rappahannock Regional Jail until sober.

#### **PUBLIC INTOXICATION**

Wawa, 9 South Gateway Drive – Deputy responded to an intoxicated person call. The caller advised there was a male who appeared intoxicated and was "freaking everyone out." The deputy located the suspect, who was actively smoking a rolled-up burnt dollar bill. He had signs of intoxication and therefore was charged with public intoxication. He was held at Rappahannock Regional Jail until sober.

#### **DISTURBANCE**

Stafford Regional Handbell Society, 106 Banks Ford Parkway – A deputy was in the area with a disabled vehicle when she observed a loud disturbance occurring. The deputy made contact with the two parties involved; the female was detained and eventually charged with obstruction of justice. The male was charged with assault and battery for slapping the female before deputies arrived. The female was held at Rappahannock Regional Jail on a secured bond while the male was held without bond.

#### **VANDALISM**

England Pointe Drive. The victim advised they were inside their residence when someone attempted to kick in the front door.

Ridge Pointe Lane – A deputy responded to a vandalism. Despite the high price of eggs, multiple vehicles were egged overnight.

#### **WARRANT SERVICE**

I-95 Southbound at mile marker 137 – A deputy was on a traffic stop when he observed one of the occupants was a wanted suspect. The suspect was wanted out of Frederick County for a probation violation for dangerous drugs. The suspect would provide a false identity in an attempt to avoid capture, but it did not work. He was charged with obstruction of justice, providing a false identity to law enforcement, identity fraud, and unlawful name change. He was also served on his outstanding charge and held at Rappahannock Regional Jail without bond.

#### **WEAPON OFFENSE**

Area of Warrenton Road and Olde Forge Drive – Deputy responded to a disturbance. The caller advised while coming home from Captain D's, a red Prius cut her off and brandished a firearm.

# **BRAVO ZONE**

#### **CRIMINAL ACTIVITY**

Maple Street – A deputy responded to an abduction. The reporting party advised she received a call from someone advising her that her aunt had been kidnapped. The deputy investigated the matter and determined no abduction had taken place and the aunt was fine at work. The deputy explained to the reporting party this was a common scam where scammers use scare tactics to obtain personal information or money.

#### **ASSAULT**

Forbes Street – Two (2) juvenile females, who had ongoing issues with each other, participated in an arranged fight. As a result, a criminal complaint for assault and battery was filed for them both.

#### **LARCENY**

O'Reilly Auto Parts – Staff advised a male suspect attempted to purchase multiple items with a company check. Staff contacted the company and found that the checkbook had been stolen, and staff refused to give the suspect the items. The suspect, in turn, stole the items.

#### DUI

Area of Richmond Highway and Centreport Parkway – A deputy was traveling in the area when he observed a vehicle traveling at speeds above 75 MPH and making jerky movements. The deputy conducted a traffic stop and found the driver to have signs of intoxication. The drive admitted to having "one beer", and was charged with driving under the influence, refusal, and reckless driving. He was held at Rappahannock Regional Jail until sober.



# **CHARLIE ZONE**

#### **DLARCENY**

Dalo Motors, 3001 Richmond Highway – Staff advised an unknown male entered the business, took keys to a Hyundai Sonata, and drove off in the vehicle.

7-Eleven, 3623 Richmond Highway – Staff advised a male suspect stole over \$1,800 worth of lottery ticket rolls.

#### **VANDALISM**

Stafford School Board, 31 Stafford Avenue – A Mercedes had its windshield cracked. Using camera footage, it was discovered a male suspect walked up to the innocent Mercedes and punched the windshield before walking away.

Stafford School Board, 31 Stafford Avenue – A second innocent vehicle sustain windshield damage.

Sunny Hill Court – The victim advised her front door was kicked in. It was also discovered, using Ring footage, that the suspect assaulted the victim's vehicle with a pipe shaped object.

Norman Road – The victim advised when she called her dog to come inside, the dog was discovered to have purple paint on it.

Pilot Knob Loop – The caller advised a male was stomping on the back windshield of a vehicle. A deputy made contact with the suspect, who advised he did nothing wrong despite the clearly damaged vehicle that was not his. The suspect also had signs of intoxication. He was charged with public intoxication and destruction of property. He was held at Rappahannock Regional Jail until sober.

#### **ASSAULT**

Terrace Drive – The victim was involved in a minor fender-bender with the suspect. Instead of exchanging insurance information, the suspect exchanged hands. The victim was not hurt in the auto accident or the assault. The case is under investigation.

#### DUI

3600 block of Richmond Highway – A Camry was crushed by a work truck. The deputy made contact with the Camry driver who had signs of intoxication and advised "I had a lot of liquor." Apparently "a lot" meant between 12 and 15 shots. He was charged with driving under the influence. After being transported to a local hospital for his minor injuries, he was transported to Rappahannock Regional Jail where he was held until sober.

#### **PUBLIC INTOXICATION**

Subway, 475 Aquia Towne Center – The deputy made contact with the suspect, who stumbled over his takeout bag, and the deputy discovered the suspect was intoxicated. The suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Genesis Logistics, 705 Bradburn Place – Two (2) employees were involved in a verbal argument in which one of the employees was intoxicated. Despite that, and his clear signs of intoxication, the suspect advised there was "no problems, no issues." Deputies thought otherwise and the suspect was charged with public intoxication.

# **DELTA ZONE**

#### **VANDALISM**

Susan Street - Two (2) vehicles had their tires slashed.

Target, 1090 Stafford Market Place – The victim advised after exiting the business he observed scratches to his Mazda.

George Walker Drive – The victims advised while traveling in the area their van was struck by rocks thrown by two (2) individuals. The suspects were located and both were charged with vandalism to commercial property and throwing a missile at a moving vehicle. Both were held at Rappahannock Regional Jail on a secured bond.

#### **WARRANT SERVED**

Mine Road – A male wanted for a probation violation was in the area. The deputy made contact with the suspect and detained him. During a search incident to arrest, the deputy located a fake driver's license out of North Carolina. The suspect was served on his outstanding warrant, as well as, possession of a fictitious license. He was held at Rappahannock Regional Jail without bond.

#### **BREAKING AND ENTERING**

Foxwood Village Mobile Home Rental Office, 7 Foxwood Drive – The office was forcibly entered and documents were taken. Using camera footage, it was discovered two (2) male suspects were involved in the incident that occurred at approximately 5:50 a.m. that morning.

#### **LARCENY**

2000 block of Garrisonville Road – A deputy responded to a rooster on the loose. The victim advised a \$200 rooster statue was stolen. The clucking suspect is still on the loose.

Kohl's, 1220 Stafford Market Place – Staff advised a known shoplifter had returned. This time he walked out with over \$220 worth of items.

Target, 1090 Stafford Market Place – A deputy responded to a sucky larceny. Staff advised a male suspect, known for stealing vacuums, was stealing yet another. The deputy located the suspect in possession of the stolen vacuum and detained him. The streets were cleaned up when the suspect was charged with shoplifting and held at Rappahannock Regional Jail without bond.

#### **ALCOHOL OFFENSE**


Jeff Rouse Center, 1600 Mine Road – A deputy was in the area when he observed a vehicle occupied by a male and female. Considering the early morning hours, it was unlikely the pair were there for swimming lessons, so the deputy made contact with them. The male was discovered to be in possession of Twisted Teas and had given the female some to consume. He was issued a summons for underage possession of alcohol and contributing to the delinquency of a minor. The female was turned over to a family member.

# SCAM-AWARE

**Victim** received a call approximately 3 to 4 weeks ago from a subject by the name of "Jason Marley", who advised they were with Publisher's Clearing House. They told him he was eligible for \$4.5 million and a Mercedes-Benz vehicle. They then began giving him instructions on how to transfer money to them using Green Dot cards, VISA gift cards, and Apple gift cards. The victim made three (3) transfers to a bank account, a total of \$31,000, and they provided him with a name, address, routing number, and account number for the person receiving the transfer. Once the transfers were completed, the victim realized he had been scammed.


**Victim** received a phone call from a coworker who was in contact with an individual she believed was her boss. Because the coworker was at the airport, she asked the victim to help their "boss", and passed along the number she had been contacted from, which she believed was a second contact for their boss. The victim then reached out to this number and received instructions via text to go to the store and buy Apple gift cards. The victim purchased the gift cards and sent pictures of the front and back to the number as instructed. The victim then received instructions to go back into the store to purchase another card for \$500. At this point the victim became suspicious of the instructions and the number she received them from. The victim began suspicious and made a call to Apple through the number provided on the card and explained the situation. The funds had not been spent yet and cards were frozen by Apple. Apple then directed the victim to contact their local law enforcement.


