ALPHA ZONE

ASSAULT

Nobel Court, deputies responded to an assault. Two (2) females were engaged in a verbal argument when one of them began physically assaulting the other. In retaliation, a male and juvenile female began assaulting the predominant aggressor. The predominant aggressor was charged with assault and battery. She was released by the magistrate on personal recognizance. A warrant for assault by mob was obtained for the male, but has not yet been served. A criminal complaint for assault by mob was filed for the juvenile female.

Kassy Lane, deputy responded to an assault. Continuing with the lover's quarrel theme, it was discovered the victim got into an argument with his girlfriend. The argument escalated when the girlfriend assaulted him. The suspect was charged with assault and battery. She was released on a summons.

PUBLIC INTOXICATION

Stonehaven Drive, deputy was on scene of a disturbance when he observed a male suspect taking a mud bath. The 38-year-old had signs of intoxication and admitted to typically drinking 10 to 12 "regular beers." Considering this, and the fact most sober people don't roll around in the mud at 3:00am in the morning, he was arrested for public intoxication. He was held at Rappahannock Regional Jail until sober.

DUI


Walmart, Il Village Parkway, deputies responded to an unknown problem. It was advised a female had taken an unknown number of pills and was getting behind the wheel. While responding, deputies observed the suspect vehicle enter the Walmart parking lot and the suspect get out. When deputies attempted to make contact with the suspect, she fled on foot into the business. She was quickly detained before reaching the produce aisle and discovered to be under the influence. She was charged with driving under the influence and fleeing from law enforcement. She was held at Rappahannock Regional Jail until sober.

Mr. B's, 375 Warrenton Road, deputy was traveling on Warrenton Road when he observed a vehicle traveling 60 MPH in a 45 MPH zone. He conducted a traffic stop and found the driver had signs of intoxication, admitted to consuming beer prior to driving, had an open container, and suspected controlled substances were located in plain view. It was also discovered he possessed no driver's license. The driver was charged with driving under the influence, possession of controlled substances, drinking while driving, driving without a license, and speeding. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

LARCENY

Target, 25 South Gateway Drive, deputy responded to a larceny in progress. Staff advised a suspect they are very familiar with was currently filling his cart with appliances. The deputy made contact with the suspect, who provided a false identification. It was discovered why he was trying to be someone else, for he had warrants for larceny out of both Stafford and Fairfax. He was detained and found to be in possession of burglary tools. He was charged with attempted larceny with intent to sell, providing a false identification to law enforcement, possession of burglary tools, as well as, served on his outstanding warrants. He was held at Rappahannock Regional Jail without bond.

DUI

Intersection of Richmond Highway and Hospital Center Boulevard, deputy was traveling in the area when he observed a Nissan traveling in a less than acceptable way. The deputy conducted a traffic stop and the driver had signs of intoxication and admitted to consuming "a couple beers" before getting behind the wheel. He was charged with driving under the influence with a blood alcohol content between .15 and .2. He was held at Rappahannock Regional Jail until sober.

LARCENY

Snow Drive, deputy responded to a larceny. The victim advised she hired a cleaning company to clean her house. When she returned home, she discovered while her home was spotless, her engagement ring was nowhere to be found. The investigation is ongoing.

Stafford Hospital, 101 Hospital Center Boulevard, deputy responded to a larceny. The victim advised her vehicle was stolen while she was in the hospital.

FRAUD

Circle K, 34 Prosperity Lane, deputy responded to a phony money report. Staff advised a male suspect attempted to pay with a counterfeit \$100 bill. Considering its poor quality, they refused his sale. As the deputy was leaving, he was informed of the same set of circumstances just occurred down the street at 7-Eleven, 378 Garrisonville Road. There, the suspect tried to pay with a poorly made counterfeit bill and was refused. The suspect was described as a black male with dreads driving a small black sedan.

LARCENY

Ulta, 1150 Stafford Market Place, deputy responded to a larceny. Staff advised a larceny occurred the day prior where a female suspect stole over \$3,600 worth of items.

Kohl's, 1220 Stafford Market Place, deputy responded to a larceny. Staff advised a male suspect stole nearly \$680 worth of items. The deputy was able to identify the suspect and obtained a shoplifting warrant for him.

Target, 1090 Stafford Market Place, deputy responded to another larceny. Staff advised a male suspect stole over \$1,000 worth of items. The deputy was able to easily identify the suspect considering he was the same suspect as the previous larceny. A warrant for felony shoplifting was obtained.

7-Eleven, 378 Garrisonville Road, deputy responded to a larceny. Staff advised three (3) female suspects stole a bottle of wine. Luckily, the females stopped to smile big for surveillance cameras giving the deputy a good look at the suspects.

ASSAULT

Wawa, 15 Eustace Road, deputy responded to an assault. It was discovered the victim was driving in the area when the suspect hit his vehicle. The victim confronted the suspect on the hit and run in the Wawa parking lot when the suspect assaulted him. Warrants for hit and run, as well as, assault and battery were obtained but not yet served.

Quickway, 1475 Prosperity Lane, deputy responded to an assault. It was discovered the victim was out to dinner with her boyfriend when an argument broke out. The argument escalated when the boyfriend assaulted her. The suspect was located nearby and was charged with assault and battery. He was released by the magistrate on personal recognizance.

DUI

Sheetz, 1175 Garrisonville Road, deputy responded to a drunk driver complaint. The caller advised an intoxicated male was driving a blue pickup truck in the area. The deputy located the truck and driver in the Sheetz parking lot. The driver had signs of intoxication and admitted to having an "Alabama Slammer." It appears Stafford's reputation had reached all the way to Sweet Home Alabama considering the driver would refer to deputies as "Stafford's finest." He was charged with driving under the influence and held at Rappahannock Regional Jail on a \$2,000 secured bond.

SCAM-AWARE

Victim responded to an advertisement for Cane Corso puppies on TikTok and in response received the number 315-256-0286 to contact to purchase the puppies. The victim advised that he contacted the number and made a deal for \$1800.00 and asked to see proof of ID and paperwork from the breeder who identified herself as Janet Kay Dean of West Virginia. The victim was sent an image of Janet Deans West Virginia driver's license and a "West Virginia Department of Agriculture Class A Breeder certificate." The victim sent payment through Zelle payment to "Chiani Williams" in the amount of \$1300.00 then another \$500.00 CASHAPP payment to a different phone number, 646-883-4607. After the transaction was completed the victim started feeling uneasy and thought he may be victim to a scam. He described the voice on the phone he made a deal with as a male voice with a Pakistani accent even though the photo ID provided was clearly a 71-year-old Caucasian female. He also called AKC breeding authorities and was told that there was no such license issued to Janet Dean and that the document he received was fraudulent. Once the victim reported the scam to the Sheriff's Office, the numbers the victim originally communicated with no longer worked.

Victim stated he received a phone call from 888-579-4065, advising they were with "Innovative Health Plans". The individuals over the phone advised the victim's coverage with Medicaid was going to expire and he needed to pay \$242.90 in order to renew his coverage with Medicaid. The victim paid the amount of \$242.90 over the phone with his Chime debit card number. The victim then received a letter advising him his Medicare coverage had been terminated. The victim contacted Medicaid, who advised him they would never reach out to him and ask him to pay to renew the coverage. The victim attempted to contact the number back who advised they were "Innovative Health Plans" but he was unable to get through and that is when he figured he had been scammed.

Victim received an email on August 17th from someone identifying themselves as Publishers Clearinghouse. Per the email, the victim won, among other things, approximately \$7.5 billion, and just needed to pay some small fees for taxes to claim his prizes. The victim then contacted the suspects via phone, and they advised him they needed \$1000 in gift cards before he could receive said prizes. After obtaining the gift cards, the suspects requested the victim scratch off the area for the serial and send them photos of said serials, but advised that, since he still retained the card itself, the money couldn't be spent. The victim did so, and the suspects followed up two (2) more times, requesting \$400 in gift cards each time. Finally, the prizes were supposed to be delivered on September 9th, but the suspects advised it was delayed. Consequently, they requested an additional \$1700 to continue moving the process along. The victim became highly suspicious at this point, stated he didn't have and wouldn't provide those funds, and then called Publisher's Clearinghouse to confirm whether he had been scammed. Unfortunately, they confirmed this to be a scam.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest.
