# **ALPHA ZONE**

# DUI

Area of Poplar Road and Truslow Road. A deputy observed a swerving Sonata and a traffic stop was conducted. The 28-year-old driver had signs of intoxication, admitted to consuming "a couple shots" of tequila, and had a juvenile passenger. She was charged with driving under the influence with a blood alcohol content between .15 and .2 with a child, as well as, traffic lane violations.

Target, 25 South Gateway Drive. A deputy responded to a disturbance. The caller advised the driver of a "boxy" vehicle was screaming "he worships the devil!" While Satan was not located in the parking lot, the deputy located the boxy vehicle and made contact with the driver. She had signs of intoxication, so field sobriety tests were conducted. Shortly after, the driver was detained and charged with driving under the influence.

# **LARCENY**

Walmart, 11 Village Parkway. Staff advised a male suspect was stealing Magic the Gathering cards. When the suspect attempted to abracadabra away, he failed and was caught. The deputy issued the wandering wizard a summons for shoplifting.

Walmart, 11 Village Parkway. Staff advised a male suspect walked out of the store with nearly \$180 worth of items. The suspect did not make it far, he was found across the street at Royal Farms. The suspect was issued a summons for shoplifting.

# **THREATS**

Americas Best Value Inn, 605 Warrenton Road. A Deputy responded to a call regarding threats. The victim advised he broke up with his now ex-girlfriend last night. In response, she sent threatening messages, including a picture of a firearm. One (1) felony warrant for threats of death will be obtained.

# **DRUGS**

Area of Plantation Drive and Smokehouse Drive. Deputies observed a vehicle run a red light on Warrenton Road and attempted to conduct a traffic stop. While it took a while for the driver to pull over he finally did. The driver had no driver's license, and during a search of the vehicle, a suspected controlled substance was located. This substance was later tested with a Tru-Narc device and was determined to be methamphetamine. At Rappahannock Regional Jail, the driver was searched and jail staff located another suspected controlled substance in his undergarments. The driver advised he took so long to pull over because he was stuffing his "skivvies". He was charged with possession of controlled substances, felony by a prisoner, driving without a license, and failure to obey a traffic light. He was held without bond.

# **PUBLIC INTOXICATION**

Sleep Inn, 595 Warrenton Road. The deputy responded to an unknown problem. Dispatch received a call with what sounded like multiple females engaged in a verbal disagreement. The deputy was able to make contact with one of the females involved, who advised the incident was over "nothing." The suspect had signs of intoxication and refused to cooperate with the investigation. Due to her level of intoxication, deputies attempted to detain her but she did not cooperate with that either. After a brief struggle, she was charged with public intoxication and obstruction of justice.

# **LARCENY**

Ashcroft Drive. A deputy responded to a larceny. The victim advised her Amazon packages were stolen on Sunday.

# **DUI**

Area of Ferry Road and Pendleton Road. A deputy observed a Mustang, fresh out of the McDonalds' drive-thru, drifting over the double yellow line. The deputy conducted a traffic stop to see if the driver was intoxicated or just too infatuated with his Big Mac. The driver had signs of intoxication and admitted to consuming three (3) bottles of Blue Moon before driving. He was charged with driving under the influence and failure to maintain the lane of travel.



# **CHARLIE ZONE**

# **ASSAULT**

Wawa, 860 Richmond Highway. It was advised a driver and passenger were in a vehicle when an unknown male approached them asking if they were his Uber. When the victims informed him they were not his ride, he, along with two (2) masked females attempted to gain entry into the vehicle. The victims were able to stop the intruders; however, they were assaulted in the process. Detectives are investigating the incident.

Brooke Point High School, 1700 Courthouse Road. The School Resource Officer was patrolling the cafeteria when he was struck in the back of the head by a juvenile. The deputy was not injured and a criminal complaint for assault and battery on law enforcement was filed. Juvenile Intake was advised of the situation and decided to detain the juvenile.

### DUI

Wawa, 860 Richmond Highway. A deputy was enjoying a meal when he observed the driver of a Camry begin to vomit. Now with a ruined appetite, the deputy made contact with the driver. The driver had signs of intoxication and after conducting field sobriety tests, the driver was taken into custody. The driver advised his mother would be "discontent" to learn he was driving under the influence. He was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

Wawa, 3099 Richmond Highway. A deputy was in the area when he observed a vehicle on Richmond Highway towing a trailer with a tire missing. Considering the trailer was riding on a rim, the deputy conducted a traffic stop. The driver had signs of intoxication and admitted to smoking a controlled substance "about an hour ago." The driver also had a suspended license. He was charged with driving under the influence, 2nd offense driving while suspended, and an illegal window tint. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

# **EXTORTION**

Macon Drive. A deputy responded to an extortion report. The victim advised after clicking on a link, she was logged out of her social media accounts. She would then receive calls demanding money to return the accounts to her control.

## **LARCENY**

Bridgewood Court. Deputies responded to a larceny in progress. The caller advised their vehicle was broken into and two (2) suspects were attempting to steal it. The suspects quickly took off on foot after being noticed. They were described as black males, one wearing a black hoodie while the other wore a black winter puffer jacket.

### **PUBLIC INTOXICATION**

7-Eleven, 2998 Richmond Highway. A deputy responded to an "intoxicated person" call. The caller advised a male, who smelled like an alcoholic beverage, was refusing to leave. The deputy made contact with the suspect, whom he knew from a previous incident, and also noticed the alcoholic odor stronger than Axe body spray. If that wasn't enough, the suspect proclaimed "I'm drunk." He was charged with public intoxication.

# **DELTA ZONE**

# **ASSAULT**

Sundance Drive. A deputy responded to an assault call. It was advised a large group of juveniles were gathered around two (2) females fighting. It was discovered that Juvenile #1 assaulted Juvenile #2 over ongoing issues between them. Juvenile Intake was advised of the situation and declined to detain juvenile #1. Instead, a criminal complaint for assault and battery was filed and she was turned over to a family member.

## **LARCENY**

Ulta, 1150 Stafford Market Place. A deputy responded to a larceny. Staff advised two (2) female suspects stole numerous perfumes.

Walmart, 217 Garrisonville Road. Staff advised a male suspect stole a safe using a backpack, also discovered to be stolen. Due to the unique features of the suspect, including his neck tattoos and large framed glasses, the deputy was able to identify a person of interest based on previous larcenies. The investigation is ongoing.

Walmart, 217 Garrisonville Road. A male suspect was switching price tags on items to pay less at the self-checkout line. The \$370 worth of stolen goods were recovered and the suspect was issued a summons for shoplifting.

Winding Creek Elementary School. A deputy was patrolling the school when he was informed of a larceny. Staff advised a dog lawn ornament was stolen. Using camera footage, it was determined the larceny occurred Friday at approximately 5:47 a.m.

Target, 1090 Stafford Market Place. A deputy responded to a trespassing. A male suspect who wasn't supposed to be there was, in fact, there. Deputies made contact with the suspect and discovered he was actively shoplifting. He also had four (4) active warrants. The suspect was charged with shoplifting, and trespassing, and served on his outstanding warrants. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.
