WEEKLY CRIME REPORT

ALPHA ZONE

DUI

The intersection of Warrenton Road and Village Parkway, deputy responded to a single-vehicle auto accident. It was discovered the vehicle went off the roadway, struck a tree stump, and rolled over until it stopped. The driver had signs of intoxication and admitted to consuming alcohol before driving. He was transported to a nearby hospital to be treated for his injuries and was charged with driving under the influence.

Waffle House, 580 Warrenton Road, deputy conducted a traffic stop on a vehicle and the driver had signs of intoxication and a cup in the center console filled with "two or three shots." He was charged with driving under the influence and held at Rappahannock Regional Jail on a \$2,000 secured bond.

LARCENY

Target, 25 South Gateway Drive, deputy responded to a larceny in progress. Staff advised a well-known shoplifting suspect was back at it, this time stealing Pair of Thieves brand items. The solo thief with Pair of Thieves was stopped after she passed all points of sale. The deputy was able to confirm the suspect involvement in three (3) previous larcenies from the same location. The suspect was charged with four (4) counts of shoplifting.

ASSAULT

America's Best Inn, 605 Warrenton Road, deputy responded to an assault. It was advised a guest was acting belligerently towards his girlfriend. When asked to leave the establishment by staff, he assaulted both his girlfriend and a staff member. Later, deputies would locate the suspect and detain him. He was charged with assault and battery and was released by the magistrate on personal recognizance.

Amazon, 220 Centreport Parkway, deputy responded to an assault. An employee assaulted another after not having the door held open for him. The suspect was issued a summons for assault and battery.

THREATS

Days Inn, 14 Simpson Road, deputy responded to a disturbance. The female victim advised she was texting a known male suspect when he requested they partake in personal relations. When she declined, the suspect threatened to shoot the victim's boyfriend. The suspect would arrive at the business and brandish a firearm. He would flee before the deputies' arrival. On September 15th, the boyfriend would also report threats made directly to him. The investigation is ongoing.

BRAVO ZONE

PUBLIC INTOXICATION

Wakefield Avenue, deputy responded to a disturbance. The caller advised an intoxicated male left his residence and was screaming. The deputy made contact with the screaming suspect, who had signs of intoxication and admitted to consuming "a few beers." He was held at Rappahannock Regional Jail until sober.

ASSAULT

Walgreens, 50 White Oak Road, deputies responded to an unknown problem. It was advised a juvenile was walking along the train tracks. As deputies attempted to check the welfare of the juvenile, he would kick a deputy in the groin. The deputy was not seriously injured and the juvenile was detained. A criminal complaint for assault and battery on law enforcement was submitted. The juvenile was detained at the Juvenile Detention Center.

Pecan Lane, 9/12, deputy responded to an assault. It was discovered a juvenile assaulted a roommate after an argument over who could sit where on the couch. A criminal complaint for assault and battery was filed.

DRUGS

Stafford High School, 63 Stafford Indians Lane, deputy was conducting her SRO duties when she was informed of drug activity. Staff discovered a student in possession of a THC vape. A criminal complaint for underage possession was submitted.

LARCENY

Walmart, 125 Washington Square Plaza, deputy responded to a larceny. The victim advised she had a brief conversation with a female suspect in the parking lot. Afterward, she noticed her debit card was missing. The victim would later receive notification of fraudulent transactions.

Walmart, 125 Washington Square Plaza, deputy responded to a larceny. Staff advised a male suspect stole cookies, a computer, and 36 rolls of toilet paper. The suspect fled the business with the makings of an amazing night in a gray sedan.

CHARLIE ZONE

PUBLIC INTOXICATION

Aquia Bay Avenue, deputy responded to a suspicious person report. The caller advised an unknown male wearing cowboy boots was on his porch. The deputy made contact with this "lone ranger", who advised he just left the "ranch" and had six (6) beers. The deputy saddled up and went on a quick mosey to Rappahannock Regional Jail with the 20-year-old. There, he was charged with public intoxication and underage consumption of alcohol.

Jay's Sports Lounge, 2866 Richmond Highway, deputy responded to a disturbance. The caller advised a known female was intoxicated and threatened to damage her vehicle. The deputy made contact with the suspect next to the innocent vehicle and discovered she was, in fact, intoxicated. The suspect was charged with public intoxication.

At the intersection of Richmond Highway and Garrisonville Road, deputy was in the area when he observed an intoxicated female on the side of the road. The deputy knew she was intoxicated due to a prior interaction and attempted to detain her. She would begin cussing, refusing commands, and demanding an ambulance to give her a ride back to her vehicle. Instead of assisting in a DUI, the deputy charged the suspect with public intoxication, disorderly conduct, and falsely summoning an ambulance.

WARRANT SERVED

Boswell's Corner, deputy observed a vehicle speeding and conducted a traffic stop. During the traffic stop, the deputy discovered the vehicle had a fictitious license plate and the driver was wanted out of Texas for a felony warrant. She was charged with fugitive from justice and possession of fictitious registration. She was held at Rappahannock Regional Jail on a \$6,000 secured bond.

ASSAULT

Rappahannock Regional Jail, 1745 Richmond Highway, deputy responded to an assault. It was advised an inmate was refusing jail staff's commands. The situation escalated when the inmate charged a staff member and assaulted them. The staff member was not seriously injured and the inmate was detained. Warrants for assault and battery on jail staff, as well as, obstruction of justice was obtained.

Rappahannock Juvenile Detention Center, 275 Wyche Road, deputy responded to an assault. A teacher was assaulted by a juvenile after addressing discipline issues. A criminal complaint for assault and battery was filed.

DUI

7- Eleven, 302 Town Center Boulevard, deputy responded to a suspicious vehicle report. The reporting party advised they observed the driver of an Audi smoking something while driving around. The deputy made contact with the driver who had signs of intoxication. When she was informed she was detained, the driver attempted to resist. It did not go as planned as she was still detained. Found in her possession of a fake driver's license. She was charged with driving under the influence, refusal, and possession was a fictitious license. She was held at Rappahannock Regional Jail without bond.

LARCENY

Wawa, 3099 Richmond Highway, deputy responded to a larceny. Staff advised three (3) female suspects stole four (4) boxes of wine. They would then leave in a white Mazda SUV.

DELTA ZONE

ASSAULT

Tobacco Hut, 44 Mine Road, deputy responded to an assault. The victim advised an unknown male tried to start up a conversation with him. When the victim informed the suspect that he wasn't interested in chatting, the suspect assaulted the victim.

Circle K, 34 Prosperity Lane, deputy responded to an assault. It was advised a female suspect pushed multiple customers while in the check-out line. Despite line cutting, the suspect would still walk out of the business with unpaid merchandise. She was charged with assault and battery, as well as, shoplifting. She was held at Rappahannock Regional Jail without bond.

LARCENY

Sheetz, 1175 Garrisonville Road, deputy responded to a larceny. The victim advised he went into the store to purchase items only to return to the parking lot to discover his vehicle was taken. The vehicle was entered as stolen into a law enforcement database. Later, the Winchester Police Department advised they located the stolen vehicle and detained the suspect involved. A warrant for grand larceny was obtained.

Publix, 1640 Publix Way, deputy responded to a larceny. The victim advised while shopping her wallet was taken from her purse. Using store cameras, it was discovered a female suspect stole the wallet. The victim would later receive notification of fraudulent activity on her credit cards.

Panera Bread, 1005 Stafford Market Place, deputy responded to a larceny. The victim advised while enjoying her meal, someone took credit cards from her purse. Those cards were subsequently used in a shopping spree at nearby stores.

PUBLIC INTOXICATION

Clore Drive, deputy responded to a disturbance. The caller advised a pajama-wearing male was stumbling down the road in the area. When the deputy arrived, he observed the pajama person nearly stumble into a ditch. The 18-year-old had signs of intoxication and admitted to consuming two (2) beers. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Walmart, 14 North Stafford Complex, deputies responded to a disturbance. It was advised there was an altercation in the parking lot and one of the involved parties appeared intoxicated. Deputies made contact with the male suspect who had signs of intoxication and admitted to consuming alcohol. Deputies also made contact with a female suspect who was wanted out of Prince William County for two (2) warrants. During their interaction, she admitted to possession of a crack pipe. Deputies located the pipe in question along with another one and suspected controlled substances. The male was charged with public intoxication and held at Rappahannock Regional Jail until sober. The female was charged with possession of controlled substances, possession of paraphernalia, as well as, served on her outstanding warrants. She was held without bond.

DUI

Foxwood Drive, deputy was in the area when he observed a vehicle missing a tire. The driver of the three-wheeled Jeep had signs of intoxication and admitted to consuming "a couple drinks" before driving. An open Corona was also located within the vehicle. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

SCAM-AWARE

Victim advised she received a call from an unknown phone number. The individual on the other end of the call was someone claiming that her Apple Account and Bank Account had been used to purchase \$10,500.00 USD worth of Adult Videos. The victim stated she spoke to two (2) different individuals over a 4-hour phone call as they passed her back and forth continuously making claims to represent Apple Services and Navy Federal Credit Union System. The victim followed their instructions for her to go to her Navy Federal Credit Union branch to withdraw \$10,000.00. The victim advised the additional instructions were for her to go to one of the three (3) local Crypto base locations to deposit the \$10,000.00. The victim complied, only afterward realizing this was a scam.



Our mission is to build trust, build better relationships and breakdown barriers as we all strive to make our community of Stafford County a community of one.


