# ALPHA ZONE

## **LARCENY**

Dollar General, deputy responded to a larceny. Staff advised at closing time a male within the store began opening food items and snacked on them. After his munching spree, he refused to pay for the items he had. The deputy made contact with the suspect who advised he was just testing the product to ensure it was good. Considering stores do not work like that, he was arrested. He was charged with shoplifting, destruction of property, and unlawful entry. He was held at Rappahannock Regional Jail on a \$4,000 secured bond where the snack options are less plentiful.

## **ASSAULT**

North Stafford High School, deputies were conducting SRO duties when a fight broke out. Five (5) females participated in the brawl after a disagreement. The fight was separated, and in the process a staff member was assaulted. Criminal complaints for assault and battery were filed for all five, as well as, the student who assaulted the staff member received an additional assault and battery complaint.

## **DUI**

Holly Corner Road, deputy responded to an auto accident. The driver was traveling Northbound in the Southbound lanes, nearly crashing into two (2) vehicles, before striking a tree. The driver had signs of intoxication and admitted to consuming "a little bit of wine" prior to driving. He was charged with driving under the influence and the traffic lane violation.

## **FRAUD**

Country Inn and Suites, deputy responded to a defrauding offense. Staff advised a female would not pay the full amount for her room. After being confronted by staff, the suspect left the scene in her Mercedes.

## **LARCENY**

England Pointe Drive, deputy responded to a food abduction. The victim ordered over \$80 of food from DoorDash. Shortly after being dropped off, a suspect steals the food. Video showed a juvenile suspect had dark hair and was wearing a gray hoodie and a yellow backpack.

## **LARCENY**

Centreport Parkway, deputy responded to a larceny. Multiple items were stolen from a construction site.

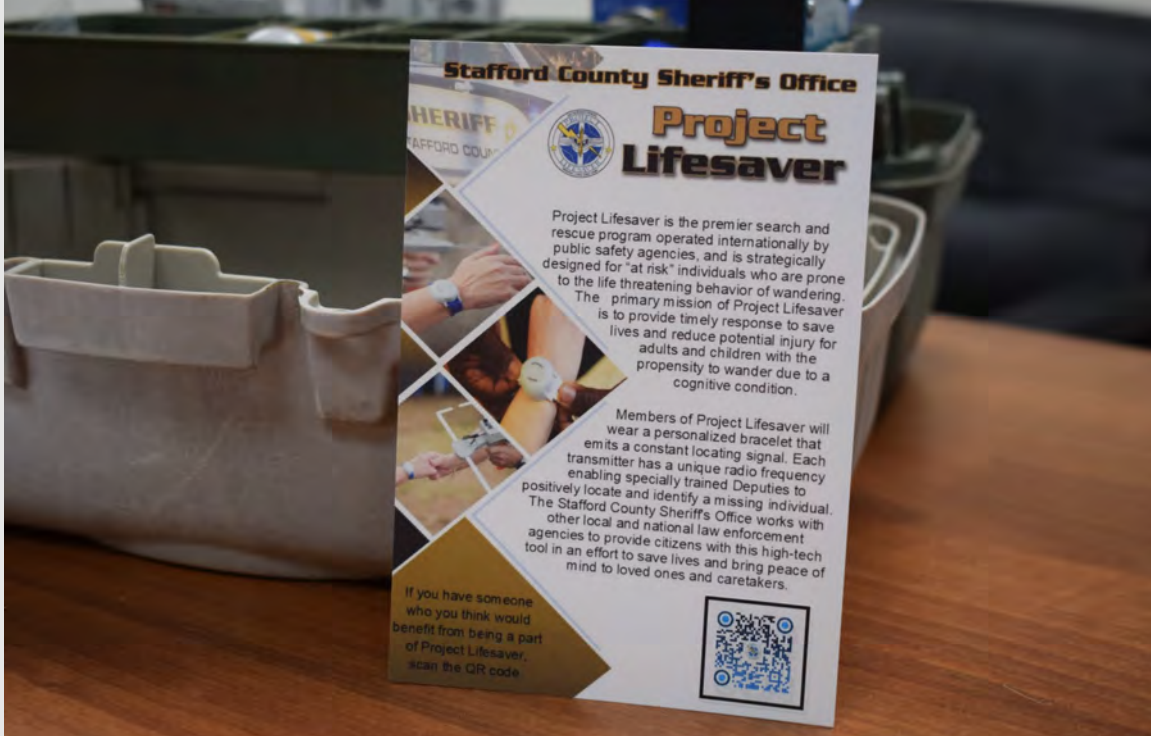
## **CRIMINAL ACTIVITY**

Monroe Avenue, deputy responded to a barking-mad threat call. The victim advised she made contact with someone on Facebook who was attempting to sell a dog. When the suspect asked for money for paperwork and vaccinations, the victim became hesitant that this could be a scam. The victim decided not to go through with the purchase and the suspect responded in a rather ruff way. The suspect advised the victim would go to jail for "puppy abandonment," used profane language, and threatened the victim.

## **LARCENY**

Walmart, deputy responded to a report of a panty pirate. Staff advised they observed a female stealing undergarments. After the underwear was recovered, the suspect received a summons for shoplifting.

## **WARRANT SERVED**

Fairfield Inn and Suites, deputy was investigating a fraud when she came in contact with a male. The male was discovered to be wanted out of Pennsylvania for felony fraud offenses. He was arrested for fugitive from justice and awaits extradition at Rappahannock Regional Jail

Ford T. Humphrey Building, 1225 Courthouse Road, deputy was handling a report in the lobby when he discovered the female involved was wanted out of Georgia. She currently awaits extradition at Rappahannock Regional Jail

## **ASSAULT**

Glacier Way, deputy responded to an assault. The juvenile victim advised he was assaulted by three (3) known juveniles. The deputy made contact with the suspects who confirmed the incident. Criminal complaints for assault and battery are pending.

## **VANDALISM**

Brenwick Court, deputy responded to a vandalism. The victim advised her vehicle was unlawfully entered and the suspect damaged the vehicle

## **DRUGS**

Rappahannock Regional Jail, deputy responded to a drug report. Jail staff located suspected controlled substances in an inmate's belongings. A warrant for a felony by a prisoner will be obtained.

## **VANDALISM**

Antietam Loop, deputy responded to a vandalism. The victim had rather rude language spray painted on his fence.

# DELTA ZONE

## **ASSAULT**

North Stafford High School, deputy was conducting his SRO duties when he walked into the boy's bathroom and discovered two (2) students actively fighting. The deputy was able to break up the fight and a criminal complaint for assault and battery for the predominant aggressor was filed.

North Stafford High School, deputy was conducting his SRO duties when he was informed of an active fight. After a brief struggle, the deputy was able to separate both females. It was discovered they both participated in mutual combat and criminal complaints for assault and battery are pending.

## **CRIMINAL ACTIVITY**

Jiffy Lube, deputy responded to a disturbance. Staff advised a customer was yelling, using inappropriate language, and walking around in an employee-only area. When staff requested she leave, she flung ashes from her cigarette on them. The suspect was identified and a warrant for disorderly conduct was obtained.

Woodlands Pool, deputy observed a vehicle traveling 40 MPH in a 25 MPH zone and conducted a traffic stop. The juvenile driver was discovered to have no driver's license and was in possession of both open containers of alcohol and marijuana. Those items were seized and the driver was turned over to his mother along with summonses for speeding, and no driver's license. Criminal complaints for underage possession of alcohol and underage possession of marijuana were filed.

Walmart, deputy responded to a disturbance. The victim advised a male showed them his firearm and said "be careful". The deputy made contact with the suspect who was found to be in possession of a firearm. During the investigation, another victim came forward advising the suspect pulled out the firearm while within the store. The suspect was charged with brandishing a firearm and disorderly conduct. He was held at Rappahannock Regional Jail on a \$5,000 secured bond. The firearm was seized.

## **WARRANT SERVED**

Popeyes, deputy conducted a traffic stop on a vehicle and made contact with the two (2) occupants. The passenger was recognized by the deputy as a wanted suspect. She was wanted out of Stafford County for two (2) failure-to-appear charges, as well as, out of Prince William County for five (5) larceny charges and one (1) obtaining money by false pretenses charge. During a search incident to arrest, she was found to be in possession of suspected controlled substances. She was additionally charged with possession of controlled substances and was held at Rappahannock Regional Jail without bond

## **LARCENY**

Edgemere Court, deputy responded to a larceny. The victim advised he allowed an acquaintance into his residence. The acquaintance said she was going to use the bathroom, but instead stole his vehicle. A warrant for grand larceny was obtained.



# SCAM-AWARE



**Victim** reported he received a call from someone pretending to be a deputy with the Fairfax County Sheriff's Office. The fake deputy informed the reporting party he missed federal jury duty and needed to pay to avoid being arrested. Luckily, the reporting party was well aware of this common scam and hung up.

**Victim** received a link through Facebook Messenger from his lifelong friend, who resides in New York State. The link was for a Federal Government Assistance Program. This link put him in contact with a subject who identified himself as Peter Bright. The victim was advised that he was eligible to receive \$100,000, but he would have to pay the processing and other fees in the amount of \$1,000 before the funds were sent to him. The victim was asked to buy two (2) Apple cards and to email the photos of both with the numbers on the back revealed to AgentPaulBishop@gmail.com. The victim complied with this request and it wasn't until he inquired as to when he was going to receive his payment that he realized it was a scam.


