DUI

Shell, 626 Warrenton Road, 6/8, 1:05 a.m. Deputy P.J. Leon was at a traffic light when he observed a sedan behind him traveling Southbound in the Northbound lanes. Deputy Leon would quickly conduct a traffic stop and made contact with the driver. The driver, at first, denied drinking anything, but later fessed up to consuming some beer. This was a given considering his signs of intoxication. The driver was charged with driving under the influence, failure to drive on the right side of the road, and refusal. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

FRAUD

Hillcrest Terrace, 6/8, 12:53 p.m. Sergeant M.E. McCann responded to a fraud. The victim advised she received a text from someone posing as her bank stating there was fraudulent activity. After using the link provided to sign into her account, the victim received real notification of real fraudulent activity.

500 block of Cambridge Street, 6/9, 8:28 p.m. First Sergeant B.U. Demirci was on a traffic stop with a vehicle that had a fictitious registration sticker. Deputy H.T. Wagner responded to assist as the driver provided the identification of a deceased person. The driver would attempt to confirm his false identity by showcasing credit cards in the deceased person's name; however, deputies were able to identify the suspended driver. He was charged with driving while suspended, having a fictitious registration sticker, identity fraud, providing a false identity to law enforcement, and two counts of credit card fraud. He was held at Rappahannock Regional Jail on a \$500 secured bond.

HIT AND RUN

Intersection of Garrisonville Road and Parkway Boulevard, 6/9, 1:39 p.m. Deputy C.S. Harding responded to an auto accident. A witness advised there was a disturbance between drivers after the crash and one of the driver's fled the scene. Deputy Harding made contact with the victim who advised a vehicle attempted to go around her but instead struck her vehicle. The at fault driver would refuse to provide insurance information and attempted to negotiate a "cash settlement."

She explained the shoes she attempted to buy didn't have a barcode, so she put them in a shopping bag. That didn't explain the over \$100 worth of items she didn't scan. The suspect was issued a summons for shoplifting.

PUBLIC INTOXICATION

Deputy Leon located the suspect, who advised he was in a rush to get to the Dollar General because the store closes at 10:00 p.m. and it was currently 9:00 p.m. When he was informed of the real time the suspect knew his shopping would have to wait. After noticing several signs of intoxication, the suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.
