ASSAULT

Paradise Court, 3/31, 1:45 p.m. Deputy R.L. Beasley responded to an assault. It was discovered a boyfriend assaulted his girlfriend after a disagreement over money. Luckily, the assault was halted by bystanders. The suspect was charged with assault and battery. He was held at Rappahannock Regional Jail without bond.

DUI

Area of Richmond Highway and Woodstock Lane, 3/30, 7:18 p.m. Sergeant A.T. Leckemby responded to a drunk driver complaint. It was advised a known party was driving a Dodge Ram in the area. Sergeant Leckemby located the vehicle in question, with both an expired registration and inspection sticker, and conducted a traffic stop. The driver had signs of intoxication and admitted to consuming "quite a few Buzz Balls." The "few" Buzz Balls were located within the vehicle, mostly consumed. The driver was charged with driving under the influence with a blood alcohol content above .2, drinking while driving, and having both an expired registration and inspection. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Enterprise Rent-a-Car, 2875 Richmond Highway, 3/31, 12:14 p.m. Sergeant A.T. Leckemby was on an unrelated traffic stop when he was interrupted by an extremely loud scraping sound. A Honda passing by had obvious damages as it drove past him. Sergeant Leckemby would catch up to the vehicle in question as it failed to maintain the lane of travel and conducted a traffic stop. The driver advised her vehicle was just "a little wonky." Wonky or not, there was considerable damage to her vehicle from an unknown source, and she displayed signs of being under the influence. The driver admitted to having "a little bit" to drink. She was charged with driving under the influence and the traffic lane violation. She was held at Rappahannock Regional Jail until sober.

Bells Hill Road, 3/31, 12:47 a.m. Sergeant A.T. Leckemby would be three for three with DUI's. While still dealing with the previous DUI, Sergeant Leckemby observed a Hyundai failing to maintain the lane of travel and informed nearby deputies. First Sergeant D.W. Fetterolf and Deputy R.T. Philippsen would locate the vehicle as the driver got out and began urinating. For obvious reasons, deputies made contact with the driver and observed signs of intoxication. An open box of

LARCENY

Goodwill, 54 North Stafford Complex Center, 3/31, 12:13 p.m. Deputy F.A. Martinez responded to a larceny. The victim advised a portable speaker was stolen off his bike while he was shopping around. Using camera footage that captured the whole incident, Deputy Martinez was able to identify the suspect and made contact with him at his residence. While at first the suspect denied stealing anything, when confronted with video evidence, he caved and admitted to the larceny. A warrant for larceny was obtained.
