ASSAULT

Edgecliff Lane, 4/11, 4:59 a.m. Deputy K.F. Bierfeldt responded to a disturbance. Two females were having a conversation about fidelity when the suspect assaulted the victim. The suspect was charged with assault and battery. She was held at Rappahannock Regional Jail on a \$2,000 secured bond.

Domino's 840 Warrenton Road, 4/11, 11:42 p.m. Deputy E.T. Osborn responded in thirty minutes or less to a saucy situation. It was discovered a meat lover wasn't exactly a staff lover, for he assaulted an employee after a supreme disagreement. The suspect was identified and a warrant for assault and battery was obtained.

DUI

Falmouth Bridge, 4/11, 12:33 a.m. Deputy I.E. Baldi was in the area when she observed a Kia run a red light. A traffic stop was conducted and Deputy Baldi made contact with the non-licensed driver. The driver had signs of intoxication and was discovered to be in possession of a suspected controlled substance. The driver was charged with driving under the influence, driving without a license, possession of a controlled substance, and the traffic light violation. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

It was advised a driver was rear-ended by a possibly intoxicated driver while waiting for a Big Mac. The driver didn't consume ice cream, maybe because the machine was broken, but did admit to consuming three drinks. He was charged with driving under the influence and refusal. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

The children were safely handed over to a responsible party as the driver was charged with driving under the influence, two counts of contributing to the delinquency of a minor, and reckless driving. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

LARCENY

Deputy Bates was able to catch 'em all and recover over \$260 worth of items. Each of the Pikachu fans received a summons for shoplifting.
