**DUI**

Sheehy Toyota, 95 Garrisonville Road, 4/13, 1:43 a.m. Deputy H.R. Perkins responded to a suspicious vehicle complaint. A security company advised despite the business being closed, a driver was in the parking lot that appeared impaired. When Deputy Perkins arrived, she located the driver asleep in the Jeep, which was still running. When the driver awoke, he had signs of intoxication and admitted to consuming "three or four beers." The driver was charged with driving under the influence and two counts of refusal. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Area of Richmond Highway and Hospital Center Boulevard, 4/13, 1:55 a.m. Sergeant B.U. Demirci was traveling in the area when he observed a Maserati traveling southbound at speeds above 100 MPH. Sergeant Demirci caught up to the vehicle on Hulls Chapel Road and conducted a traffic stop as Deputy P.J. Leon responded to assist. The driver had signs of intoxication, no front license plate, and no vehicle inspection. After field sobriety tests, the driver was charged with driving under the influence, reckless driving, two counts of refusal, improper display of a license plate, and failure to inspect a vehicle. The vehicle was towed as the driver was held at Rappahannock Regional Jail without bond.

7-Eleven, 302 Town Center Boulevard, 4/13, 11:50 p.m. First Sergeant M.R. Flick was traveling on Richmond Highway near Derrick Lane when he observed a vehicle traveling 56 MPH in a 35 MPH zone. First Sergeant Flick conducted a traffic stop as Deputy W.E. Trainor responded to assist. The driver had signs of intoxication, admitted to consuming two beers, and a bottle of vodka was located under the driver's seat. The driver was charged with driving under the influence with a blood alcohol content above .2 and reckless driving. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

Mile marker 147 of Southbound I-95, 4/13, 6:00 p.m. Deputies were traveling into Stafford County when they observed a vehicle displaying a stolen license plate. A high-risk stop was conducted and the driver was detained. The driver admitted he knew the tags were "illegal," and had no

Sergeant Demirci made contact with the occupant, who admitted to "finding" the license plate behind a dumpster. The tag was seized and a summons for larceny was issued.

### **VANDALISM**

Cavalier Skating Center, 1920 Richmond Highway, 4/13, 1:56 a.m. Deputy W.E. Trainor rolled over to a report of a vandalism. It was discovered a male kicked a glass door "out of anger," causing it to shatter. He was charged with vandalism and was released by the magistrate on personal recognizance.

Rock Hill Honey Bee Farms, 45 Pinto Lane, 4/14, 4:05 p.m. Deputy B.E. Vaughn responded to a vandalism. It was advised the property owner discovered a large number of bees deceased. A total of 50 hives were affected and the investigation is ongoing.
