**ASSAULT**

Maplewood Drive, 4/20, 12:30 a.m. Deputies responded to a disturbance. The caller advised a loud incident was occurring at a nearby residence and it sounded physical. When Deputy D.A. Robertson arrived, he discovered an assault occurred. The predominant aggressor was charged with assault and battery. He was held at Rappahannock Regional Jail until sober. While assisting in the investigation, Deputy K.F. Bierfeldt was approached by a stumbling female. The female had signs of intoxication and was causing a scene in view of the public. She was charged with public intoxication and also held until sober.

**DUI**

Giant, 550 Celebrate Parkway, 4/20, 4:00 p.m. Deputies responded to an auto accident. The caller advised a swerving Ford nearly struck pedestrians before crashing into another vehicle. Deputy J.H. Helbling made contact with the at fault driver, who "honestly don't remember" what caused the crash. Signs of intoxication were observed and Deputy D.S. Jett, a Drug Recognition Expert, conducted field sobriety tests. Shortly after those tests, the driver was detained. She was charged with driving under the influence and was released by the magistrate on personal recognizance.

**FRAUD**

Panera Bread, 1005 Stafford Market Place, 4/20, 6:08 p.m. Staff had two males attempt to pay for an order with a fake \$100 bill. The bill was quickly discovered to be a fake and the suspects quickly fled on foot. Luckily, Deputy N.J. Amato was nearby for an unrelated call and located one of the suspects. While the suspect claimed he "doesn't even eat at Panera," video evidence proved otherwise. He was charged with conspiracy of uttering and held at Rappahannock Regional Jail without bond. The other suspect has not yet been caught.

**LARCENY**

Rover Court, 4/20, 5:39 p.m. Deputy B.E. Vaughn responded to a larceny. The victim advised a known party stole multiple personal items from the residence. Warrants were obtained, but have not yet been served.

When confronted, the suspect began cursing and threatening to shoot the victim before leaving on a Fredericksburg Transit Bus. The incident was captured on camera, which Deputy Jenkins used to identify the suspect. Warrants were obtained, but have not yet been served.
