**DUI**

Deputy Perkins conducted a traffic stop and made contact with the 27-year-old driver. He had signs of intoxication and admitted to consuming "one or two shots of whiskey." The whiskey fan was charged with driving under the influence and reckless driving. He was held at Rappahannock Regional Jail without bond.
