ASSAULT

Jay's Sports Lounge, 2866 Richmond Highway, 4/24, 11:52 p.m. Deputy N.J. Amato responded to a fight between two females in which pepper spray was involved. It was discovered the victim took the suspect's keys in an effort to prevent her from driving intoxicated. In response, the suspect assaulted the victim and dragged her out of the establishment by her hair. In an act of self-defense, the victim pepper sprayed the suspect. The suspect was charged with assault and battery, as well as, public intoxication. She was held at Rappahannock Regional Jail without bond.

DRUGS

Rappahannock Regional Jail, 1745 Richmond Highway, 4/24, 9:01 a.m. Sergeant J.W. Hutcheson responded to a report of drug activity. Staff advised an inmate brought in from a neighboring jurisdiction was found in possession of an AirPods case. Instead of housing some earbuds, it was discovered to have a suspected controlled substance inside. The substance was seized and charges are pending.

FRAUD

Area of Richmond Highway and Sage Lane, 4/24, 9:06 a.m. Deputy J.L. Jones conducted a traffic stop on a Honda with an expired inspection. The driver provided a false identification, which was quickly unearthed by Deputy Jones. It was discovered the driver lied about who he was because he did not have a driver's license. The driver was charged with falsely identifying himself to law enforcement, having an expired inspection, and driving without a license. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.
