ASSAULT

America's Best Value Inn, 605 Warrenton Road, 4/25, 12:26 a.m. Deputy H.T. Wagner responded to an assault. The victim advised an argument between a known male got heated when he assaulted her and attempted to strike her with his Mazda. Security cameras confirmed the incident and a warrant for assault and battery was obtained.

DUI

Wawa, 275 Butler Road, 4/25, 2:18 a.m. Deputy C.R. Newman was in the area when a speeding Challenger caught his eye. As Deputy Newman attempted a traffic stop, the passenger decided to have a prom-like moment by standing up through the sunroof and began waving his arms in the air like he just didn't care. Deputy Newman made contact with both occupants, who had signs of intoxication and admitted to consuming a few Jim Beam and Cokes. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, as well as, speeding. The passenger was charged with public intoxication for his public display during the drive. Both were held at Rappahannock Regional Jail until sober.

Wawa, 3099 Richmond Highway, 4/25, 9:57 p.m. Deputy W.E. Trainor responded to a "hysterical" driver in the area. Deputy Trainor was able to locate the suspect and made contact with her. The driver had signs of intoxication, admitted to consuming champagne, and believed she was in Hampton City. She was informed this was Stafford County and was charged with driving under the influence and refusal. She was held at Rappahannock Regional Jail without bond.

Area of Mountain View Road and Clover Hill, 4/26, 11:36 p.m. Deputy C.A. Osborne responded to a drunk driver complaint. The caller advised a Lexus was stopped in the middle of the roadway. Deputy Osborne located the loitering Lexus and made contact with the driver. The driver advised she was just "hanging out." Given the signs of intoxication, Deputy Osborne suspected more than just hanging out was happening. After field sobriety tests, the driver was charged with driving under the influence, stopping on a highway, and refusal. She was held at Rappahannock Regional Jail on a \$3,000 secured bond.

FRAUD

Pitts made contact with the victim, who advised this Captain informed him he missed jury duty and needed to pay to avoid being arrested. There is no Captain Bone with the Stafford County Sheriff's Office and the victim was informed of the scam.

LARCENY

PUBLIC INTOXICATION

Cavalier Skating Center, 1920 Richmond Highway, 4/25, 8:31 p.m. Deputy S.T. Myers and Deputy S.M. Kotter responded to a disturbance. Instead of skating the night away, one male was causing a scene. When Deputy Myers arrived, the suspect began fleeing on foot; however, Deputy Kotter was able to block his path and detain him. The suspect had signs of intoxication, was very open about having consumed alcohol, and made derogatory remarks in the presence of other patrons. He was charged with public intoxication, disorderly conduct, and obstruction of justice. He was held at Rappahannock Regional Jail without bond.

Mega Auto Outlet, 3335 Richmond Highway, 4/26, 4:38 p.m. Deputy S.M. Kotter responded to a belligerent bargainer report. Staff advised an intoxicated male was causing a disturbance when a transaction did not go his way. Deputy Kotter located the suspect across the street at another dealership and attempted to contact him. Instead, the suspect disregarded commands and fled the area. Deputy R. Tully eventually located the suspect attempting to hide in a nearby backyard. The suspect was charged with public intoxication and obstruction of justice. He was held at Rappahannock Regional Jail until sober.

The suspect would admit to consuming a bit of tea from his Twisted Tea 12 pack. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

WEAPON OFFENSE

Jett Street, 4/26, 2:01 p.m. Deputy J.E. Cordes responded to a disturbance. The caller advised he observed a speedy Hyundai in a residential area and attempted to confront the driver. When he did, the passenger made threats to shoot him. Deputy N.D. Fonseca located the Hyundai in question finishing up a DoorDash delivery and made contact with the occupants. It was discovered the firearm was loaded and unsecured in the reach of three children in the backseat. Both the driver and passenger were charged with carrying a concealed weapon and three counts of contributing to the delinquency of a minor. The driver was released on personal recognizance while the passenger was held at Rappahannock Regional Jail on a \$2,000 secured bond.
