ASSAULT

Rappahannock Regional Jail, 1745 Richmond Highway, 4/27, 8:52 a.m. Deputy R.L. Hubbard responded to a report of an assault. An inmate was assaulted by his cellmate. The victim was transported to a nearby hospital while a warrant for assault and battery was served on the suspect.

Aquia Harbour Subdivision, 4/27, 12:21 p.m. Deputy R. Tully responded to a report of an assault that occurred in Stafford County. The juvenile victim advised he was recently assaulted by a known juvenile. Following the assault, the suspect began sending threatening messages and sent a picture of a firearm. Deputy Tully made contact with the suspect and discovered the firearm was a BB gun. Criminal complaints for assault and battery, as well as threats to kill were obtained. Juvenile Intake was contacted and they decided to detain the suspect. He was held at the Juvenile Detention Center.

DUI

Area of Richmond Highway and Courage Lane, 4/27, 1:04 a.m. A Toyota driver attempted to speed 68 MPH in a 45 MPH. First Sergeant M.R. Flick observed the offense and conducted a traffic stop as Deputy H.R. Perkins responded to assist. The driver, on his way to work, had signs of intoxication. During a search, his vehicle was discovered to be littered with multiple Modelo cans. The driver would be late to work, for he was charged with driving under the influence with a blood alcohol content between .15 and .2, drinking while driving, and reckless driving. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

When deputies arrived, they discovered damage to the front door. Using business cameras, it was discovered two males attempted to break into the business, but quickly fled when they failed.

WARRANT SERVED

Rocky Stone Drive, 4/27, 9:29 p.m. Deputies responded to a disturbance. The caller advised her "soon-to-be-ex" was there and they had a verbal disagreement. The suspect was discovered to be wanted out of Stafford County for second offense violation of a protection order. Deputies attempted to make contact with him, but shortly after making eye contact with deputies, the suspect retreated into the residence. After a brief standoff, deputies were given consent to enter the



residence. Inside they located the suspect lounging on the couch. He was served on his outstanding warrant and additionally charged with obstruction of justice. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.
