DUI

The pole basher had extremely noticeable signs of intoxication and an open alcohol container inside the vehicle. The driver was charged with driving under the influence and refusal. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

LARCENY

Wawa, 920 Wonder Road, 4/29, 11:14 a.m. Deputy J.L. Jones responded to a larceny. Staff advised shortly after using the bathroom, a male suspect stole four cases of beer.

Sheetz, 15 Wyche Road, 4/29, 10:47 p.m. Deputy D.A. Robertson responded to a suspicious person report. Staff advised it appeared a male suspect was actively shoplifting. When Deputy Robertson arrived, he located the suspect relaxing with a cup of joe outside the business. The suspect provided a false identification, which was quickly unearthed. The suspect was discovered to be wanted for a capias offense and during a search incident to arrest, multiple stolen items from the business were located in his bag. He was charged with shoplifting, providing a false identification to law enforcement, and served on his outstanding warrant. He was held at Rappahannock Regional Jail without bond.

It was advised a female was going door to door like a Girl Scout, only she wasn't selling cookies, she was requesting a ride.
