### **ASSAULT**

Butler Road, 6/16, 11:48 a.m. Deputy A.E. Epps responded to a disturbance with a weapon report. The victim advised while in the bathroom, his roommate confronted him about rent. The bathroom shakedown escalated when the roommate would attempt to strike the victim using a screwdriver. The roommate was charged with attempted felonious assault, as well as, assault and battery. He was held at Rappahannock Regional Jail without bond.

#### **DISTURBANCE**

Coopers Lane, 6/16, 10:57 a.m. First Sergeant A.I. Assur and Deputy H.H. Cassetta responded to a disturbance. It was advised a male was entering people's homes. While the suspect did not appear hostile, he was continuing his spree of unlawfully entering people's residence. He was located and charged with unlawful entry. He was held at Rappahannock Regional Jail until sober.
