ASSAULT

Fairfield Inn and Suites, 2784 Richmond Highway, 6/19, 3:48 a.m. Deputy D.S. Jett responded to a lobby ambush. It was advised that a guest assaulted a hotel staff member. The suspect would admit to lunging at the staff member like "a cat with rabies." This game of cat and mouse ended with the suspect being charged with assault and battery. He was released by the magistrate on personal recognizance.

DUI

Area of Richmond Highway and Hope Road, 6/18, 9:56 p.m. Deputy R.H. Ryan responded to a drunk driver complaint. The caller advised a Kia was swerving into oncoming traffic. The Kia was located and Deputy Ryan made contact with the driver. While the driver blamed her reckless driving on her anxiety, Deputy Ryan noticed signs of intoxication that were more likely the culprit. It was discovered she also had a suspended license. The driver was charged with driving under the influence and driving while suspended. She was held at Rappahannock Regional Jail on a \$3,000 secured bond.

Wawa, 275 Butler Road, 6/19, 11:11 p.m. Deputy S.A. Edwards responded to a drunk driver complaint. The caller advised a Lexus, with notable front-end damage, was driving recklessly. Deputy Edwards observed the laissez faire Lexus as it entered the parking lot and made contact with the driver. The driver had signs of intoxication and admitted to drinking "earlier in the evening." Her evening ended when she was charged with driving under the influence and held at Rappahannock Regional Jail without bond.

Lusterleaf Court, 6/19, 1:24 p.m. Deputy C.S. Harding responded to a larceny. The victim advised a known party stole numerous electronic devices.

Target. 1090 Stafford Market Place, 6/19, 6:44 p.m. Sergeant A.T. Leckemby responded to a cosmetic criminal. Staff advised a repeat shoplifter was back at it. Using camera footage of this incident, and one from earlier this month, Sergeant Leckemby was able to identify the mascara miscreant. The suspect, after being confronted with video evidence, handed over the stolen items and received two summonses for shoplifting.
