**ASSAULT**

When he didn't get his way, he assaulted staff. Luckily, a bystander intervened and stopped the incident. The AutoZone assaulter was charged with assault and battery. He was released by the magistrate on personal recognizance.

**DUI**

Area of Warrenton Road and Cambridge Street, 6/20, 1:16 p.m. Deputy A.E. Epps and Deputy K.L. Busch responded to an unknown problem. The caller advised there was a passed-out driver behind the wheel of a BMW. After quite a few attempts to get the driver to wake up, he finally did and deputies observed several signs of intoxication. After field sobriety tests, the driver was charged with driving under the influence. He was held at Rappahannock Regional Jail until sober.

When the driver woke up, he had signs of intoxication. After field sobriety tests, the driver was charged with driving under the influence. He was held at Rappahannock Regional Jail until sober.

A traffic stop was conducted, where it was discovered the registration would be the least of the problems. The driver had signs of intoxication, had a suspended license, and the vehicle had no inspection. She was charged with driving under the influence, driving while suspended, having no inspection, expired registration, and refusal. She was held at Rappahannock Regional Jail without bond.
