ASSAULT

White Oak Road, 6/22, 9:04 p.m. Deputy C.D. Quebedeaux responded to a truck assault. The victim advised while in the vehicle with a known male they got into a verbal argument. When the victim exited the vehicle to deescalate the situation, the male struck her with his truck. A warrant for assault and battery was obtained, but has not yet been served.

DISTURBANCE

Stafford Hospital, 1 Hospital Center Boulevard, 6/22, 6:26 a.m. Sergeant A.L. Chaves and Deputy R.L. Hubbard responded to an unknown problem. It was advised a male showed up with part of his ear missing. Due to the victim's level of intoxication, deputies were unable to determine what exactly occurred. Deputies learned one possibility was a suspect went into Mike Tyson mode and bit part of the ear off. If anyone has information, we are all ears.

DUI
