ASSAULT

Ross, 1180 Stafford Market Place, 6/24, 1:46 p.m. Instead of dressing for less one employee was dressed for a disturbance. Deputy C.M. Sterne responded to a report that an employee decided to throw a fit after being fired. He would knock items off the shelves, curse loudly, and assault the staff member who fired him. Deputy Sterne located the ex-employee and charged him with destruction of property, assault and battery, as well as, disorderly conduct. He was released by the magistrate on personal recognizance.

Lansberry Park Drive, 6/24, 10:06 p.m. Deputy S.A. Fulford responded to a disturbance. It was discovered as a resident was returning home she observed a neighbor in the middle of the road. the neighbor would rush towards her vehicle and attempt to enter it. A family member would notice the disturbance and attempt to stop the neighbor. The neighbor would then assault the family member. The suspect was charged with assault and battery, disorderly conduct, as well as, walking in the roadway. He was held at Rappahannock Regional Jail without bond.

INDECENT EXPOSURE

Sydney Lane, 6/24, 7:02 p.m. Deputy S.A. Edwards responded to an indecent exposure report. The witness advised a male was doing a private act in a not so private space. Deputy Edwards located the suspect, who admitted he "needed to relieve the stress." The suspect was charged with indecent exposure and sexual display. He was held at Rappahannock Regional Jail on a \$1,000 secured bond.

PUBLIC INTOXICATION

500 block of Cambridge Street, 6/24, 12:14 a.m. Deputy H.T. Wagner responded to a report of a woman wandering in the road. When he arrived, he observed the suspect walking Northbound in the middle of the road. Due to the obvious safety concern, Deputy Wagner made contact with her. The suspect advised she was dropped off by a cab back in February and she wanted to find a Wawa. It was clear she was under the influence and was detained. She was charged with public intoxication and walking in the roadway. She was held at Rappahannock Regional Jail until sober.
