**DUI**

Ferry Road, 6/1, 6:15 p.m. Deputy K.W. Suter responded to a drunk driver complaint. A fellow deputy, who was off-duty, observed a vehicle traveling in the opposite lane of travel and nearly hit another vehicle. The off-duty deputy followed the suspect vehicle until Deputy Suter could make contact with the driver. The driver had signs of intoxication and admitted to consuming three drinks prior to driving. The driver was charged with driving under the influence and held at Rappahannock Regional Jail on a \$1,000 secured bond.

The caller advised an "extremely intoxicated" male just left the business in a Dodge Ram. He was charged with driving under the influence and refusal. He was held at Rappahannock Regional Jail pending his ability to participate in a bond hearing.
