Deputy Steinway made contact with the driver as he entered the parking lot of the business, parking across two parking spots. Despite the erratic driving behavior and signs of intoxication, the driver denied consuming alcohol. His blood alcohol content would provide a different answer. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2. He was held at Rappahannock Regional Jail on a \$1,000 secured bond.

By the time Deputy Philippsen made contact with the suspect, the box was almost entirely consumed. After further review of the play using store cameras, it was discovered this was certainly not his first wine offense. Deputy Philippsen obtained eight warrants for shoplifting. The suspect was held at Rappahannock Regional Jail on a \$3,000 secured bond.
