DUI

Area of Richmond Highway and Sage Lane, 5/17, 7:59 p.m. Deputy J.H. Helbling was patrolling the area when he was flagged down by a couple. The pair advised him of a Lexus swerving while traveling Northbound. Deputy Helbling was able to locate the weaving vehicle a minute later and observed its zigzagged driving. A traffic stop was conducted and contact was made with the driver. The driver had signs of intoxication and admitted to consuming a beer and coffee. This unusual Irish Coffee mixture would cause the driver to be charged with driving under the influence, failure to maintain the lane of travel, and refusal. He was held at Rappahannock Regional Jail until sober.

CVS, 1 McWhirt Loop, 5/17, 10:14 p.m. Deputy I.E. Baldi responded to a reckless driver. The caller advised a Jeep was traveling on the wrong side of Warrenton Road before striking a median. Despite the crash, the Jeep continued on until Deputy Baldi located it and conducted a traffic stop. The driver had signs of intoxication and admitted to consuming three glasses of wine during a comedy show. This incident wouldn't be as comedic, as she was charged with driving under the influence and failure to drive on the right side of the road. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.
