ALCOHOL OFFENSE

Area of Courthouse Road and Wyche Road, 5/18, 11:50 a.m. Deputy J.L. Jones was in the area when he observed a Nissan with an expired inspection. During the traffic stop, Deputy Jones observed the 20-year-old driver had an open alcoholic beverage in his possession. That said alcohol was poured out and the driver was issued summons for drinking while driving, underage possession of alcohol, and the original offense of an expired inspection.

DUI

Area of Warrenton Road and Cambridge Street, 5/18, 5:42 a.m. Deputy W.J. Newton responded to an unknown problem. The caller advised the driver of a Honda was stopped at the intersection and was passed out. After deputies arrived and the driver woke up, they noticed signs of intoxication. The driver would admit to consuming "two to three" shots and an open bottle of tequila was located in the vehicle. When it was time to place the driver into handcuffs for the early morning DUI, he began to resist. His resistance did not help and only added to the list of charges. The driver was charged with driving under the influence and obstruction of justice. He was held at Rappahannock Regional Jail until sober.

Area of Deacon Road and Harrell Road, 5/18, 3:19 p.m. While Harrell Road is known for its massive flooding problems, Deputy M.N. Sayegh responded to the area for a reckless driver complaint. The caller advised a Kia was all over the roadway traveling at unusual speeds. The caller further advised they witnessed the driver, wearing a black jumpsuit, stumble out of the vehicle. Deputy Sayegh made contact with the jumpsuit lover and observed signs of intoxication. After field sobriety tests, the driver was charged with driving under the influence. She was held at Rappahannock Regional Jail on a \$2,000 secured bond.

LARCENY

ABC, 43 Town and Country Drive, 5/18, 1:23 p.m. Deputy W.J. Newton responded to a larceny. Staff advised an elderly male slipped a cheap bottle of whiskey into his pants. Staff attempted to have him pay for the bottle; however, he instead fled in a Dodge SUV.

PUBLIC INTOXICATION

Bitez, 375 Warrenton Road, 5/18, 4:02 a.m. Deputy C.R. Newman responded to a recipe for disaster. The caller reported she was involved in a verbal disturbance with two males after they requested “baking soda.” The cookie connoisseurs were not located; however, when Deputy Newman made contact with the caller, he observed signs of intoxication. She would confirm his suspicion that alcohol was involved when she proclaimed “I’m drunk.” She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Allatoona Lane, 5/19, 9:22 p.m. Deputy S.M. Kotter responded to a sleepy suspect. It was advised a male was napping in the grass near the intersection. Deputy Kotter located the suspect, who had several obvious signs of intoxication. The suspect would demand contact with the CIA was made and arresting him would be a “mistake.” It in fact was not a mistake and the suspect was charged with public intoxication. He was held at Rappahannock Regional Jail until sober.
