ASSAULT

Woodland Drive, 5/20, 6:13 p.m. Love thy neighbor would not be the case for the report of an assault Deputy J.J. Holetzky responded to. It was discovered a verbal disagreement occurred between neighbors. The disagreement escalated when the suspect struck the victim. The incident was captured on camera and will surely make the neighborhood barbecue awkward. The predominant aggressor was charged with assault and battery. While he was originally given an unsecured bond, after starting an argument with the magistrate, the decision was quickly changed. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

DISORDERLY CONDUCT

Amherst Avenue, 5/20, 6:15 p.m. Deputy S.C. Steinway responded to a disturbance in progress. It was discovered a juvenile responded to another juvenile's house to "resolve their difference" in person. This did not include a polite conversation over tea. The juvenile's mother would engage in the disturbance, further exacerbating the disturbance. She was charged with disorderly conduct and contributing to the delinquency of a minor. She was released by the magistrate on personal recognizance. The juvenile was issued a criminal complaint for disorderly conduct.

DUI

Sleep Inn Motel, 595 Warrenton Road, 5/20, 12:51 a.m. While you can expect people to be napping at the Sleep Inn, one sleeper caught Deputy W.E. Trainor's eye. While in the area for an unrelated call he observed a female driver with her head hanging out of the door of a running Kia. Deputies turned the vehicle off to prevent the driver from rolling off and made contact with the driver. After the driver woke up, deputies observed signs of intoxication and she would admit to consuming a mixed drink and a shot. She was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

Target, 1090 Stafford Market Place, 5/20, 11:39 a.m. Deputy A.J. Layug responded to a repeat offender. Staff advised a male suspect, known to them for shoplifting, was once again back at it. The shoplifting offenses date back all the way to February, and each time the suspect stole personal
