ASSAULT

He was transported to a nearby hospital with broken bones. Warrants for malicious wounding, assault by mob, and conspiracy to maliciously wound were obtained for both suspects.

Two students were involved in a verbal disagreement when things escalated by the suspect assaulting the victim. As staff attempted to separate the pair, the suspect's sister jumped in and also assaulted the victim. Both were issued a criminal complaint for assault and battery.
