ASSAULT

Walmart, 125 Washington Square Plaza, 5/24, 10:58 p.m. Deputy S.C. Steinway responded to a fight. It was discovered one employee was upset with another after being written up. The suspect told a witness he would “deck” the victim in order to “teach him a lesson.” When the victim exited the store, the suspect assaulted him. The predominant aggressor was charged with assault and battery. He was released by the magistrate on personal recognizance.

DUI

Wendy's, 145 Garrisonville Road, 5/25, 11:57 p.m. Deputies were stopped at the intersection of Garrisonville Road and Mine Road due to a red light. Despite the red light and deputies in the area, a driver decided to run the red light. A traffic stop was conducted and deputies made contact with the driver. The driver had signs of intoxication and admitted to having a shot and “some sips of someone else's drink.” After field sobriety tests, the driver was charged with driving under the influence and failure to obey a traffic light. He was held at Rappahannock Regional Jail until sober.

FRAUD

Madison Court, 5/24, 9:10 a.m. Deputy C.D. Sullivan responded to a scam. The victim advised she received a call from someone who convinced her there were numerous fraudulent charges to her bank account. These “charges” included an Airbnb payment and tickets to an amusement park in Dubai. After providing her information to the suspect on the phone, they would fraudulently withdraw money from her account.

Cedarview Court, 5/24, 12:54 p.m. Deputy N.D. Fonseca responded to an extortion scheme. The victim advised he received text messages from someone claiming to be a part of a cartel. This counterfeit cartel criminal demanded money be sent via Zelle or the victim and his family would be harmed.

ABC, 43 Town and Country Drive, 5/24, 6:12 p.m. Deputy C.D. Quebedeaux responded to a larceny. An observant customer noticed a male conceal a bottle of vodka and walk out with it. the investigation is ongoing.

Walmart, 217 Garrisonville Road, 5/25, 2:48 p.m. Deputy C.D Sullivan responded to a larceny. Staff observed a male suspect conceal jewelry into his pants. The jewelry, valued at \$150, was recovered and it was discovered the 19-year-old suspect was also in possession of cigars. He was charged with shoplifting and underage possession of tobacco. He was held at Rappahannock Regional Jail without bond.

PUBLIC INTOXICATION

Cross Ridge Court, 5/23, 3:56 p.m. Deputy X.D. Bates responded to a disturbance. The suspect, in an intoxicated state, got into a verbal disagreement with his girlfriend. While conversing with the suspect, he would attempt to convince Deputy Bates that drinking in public was not a crime. Virginia Code 18.2-388 states otherwise and Deputy Bates charged the suspect with public intoxication. He was held at Rappahannock Regional Jail until sober.

Sleep Inn Motel, 595 Warrenton Road, 5/24, 2:32 a.m. Deputy M.A. Holub responded to a disturbance. It was advised a male guest was giving staff some trouble. Deputy Holub located the suspect in view of the public in an intoxicated state. The suspect would further admit the drink currently in his hand was full of alcohol. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Shoppers, 1505 Stafford Market Place, 5/24, 5:54 p.m. Deputy X.D. Bates responded to a sloshed shopper at Shoppers. When Deputy Bates arrived, he located the suspect taking a nap in the parking lot. The suspect, who Deputy Bates knew from previous public intoxication calls, was once again charged with public intoxication. He was held at Rappahannock Regional Jail until sober.
