ASSAULT

Quality Inn, 28 Greenspring Drive, 5/26, 12:24 a.m. Deputy J.J. Holetzky responded to an assault. It was discovered the boyfriend assaulted his girlfriend over an argument about his ex-girlfriend. The male was determined to be the predominant aggressor and was charged with assault and battery. He was released by the magistrate on personal recognizance.

Brooke Point High School, 1700 Courthouse Road, 5/27, 12:29 p.m. Deputy D.J. Taylor was conducting his SRO duties when he was informed of an assault. The victim advised another student, who she had no prior contact with, decided to assault her. Using school cameras, Deputy Taylor was able to confirm the assault and identify the student. A criminal complaint for assault and battery was submitted.

Cherry Laurel Drive, 5/27, 6:48 p.m. Deputy H.H. Cassetta responded to a fight. The caller advised they had witnessed two males jump out of a vehicle and chase down another male. After tackling the victim, they began assaulting him before all parties separated. When Deputy Cassetta arrived, no victim or suspects were on scene. The driver had various accounts as to what happened; in addition to exhibiting signs of intoxication. He would also have the license plate of another vehicle displayed on his totaled vehicle. The driver was charged with driving under the influence, two counts of destruction of property, and improper display of a license plate. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.
