**ASSAULT**

Rappahannock Regional Jail, 1745 Richmond Highway, 5/4, 10:15 p.m. Deputy H.H. Cassetta responded to the jail for an assault. It was discovered while one inmate was enjoying some late-night television, another inmate stormed up to him and began a fight. The predominant aggressor was charged with malicious wounding.

**DRUGS**

Manheim Auto Auction, 120 Auction Drive, 5/5, 9:56 p.m. Deputy C.A. Osborne responded to a drug activity report. Staff advised they located a small baggie filled with suspected controlled substances. After finding the bag, a male came back to the business advising he misplaced his bag of cocaine. For obvious reasons, the suspect fled after being informed deputies were going to be notified. If the male who lost his cocaine would like to converse with Deputy Osborne about the incident, he is welcome to stop by the Sheriff's Office.

**DUI**

Sheetz, 1175 Garrisonville Road, 5/4, 1:13 a.m. First Sergeant N. Zotos and Deputy A.M. Oliveira responded to a drunk driver complaint. The caller advised a clearly intoxicated male was in the business and about to drive off. Deputies arrived as the suspect attempted to drive out of the parking lot and conducted a traffic stop. The driver had signs of intoxication and was detained. He was charged with driving under the influence with a blood alcohol content between .15 and .2. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

McDonald's, 5/4, 3:24 a.m. Deputy S.A. Edwards was stopped at the Garrisonville Road and Mine Road intersection. While there, he noticed a Toyota that was slowly inching forward despite having a red light. After checking to ensure no one was watching, the suspect ran the red light. He didn't check hard enough and Deputy Edwards conducted a traffic stop. The driver advised he was "confused" by the traffic light. The difference between red and green was explained and Deputy Edwards noticed signs of intoxication coming from the driver. The driver advised he consumed "a few" beers. He was charged with driving under the influence and disobeying a traffic light. He was held at Rappahannock Regional Jail on a \$1,000 secured bond.

Area of Richmond Highway and Enon Road, 5/4, 4:12 a.m. Sergeant R.W. Jones with the Traffic Safety Unit observed a reckless driver traveling Southbound and conducted a traffic stop. Deputy C.R. Newman responded to assist. The driver advised his reckless nature was due to him having to use the restroom; however, the signs of intoxication appeared to be a more likely culprit. The driver admitted to consuming two Modelos prior to driving. He was charged with driving under the influence and held at Rappahannock Regional Jail on a \$1,000 secured bond.

Confederate Way, 5/4, 10:10 p.m. Deputy D.A. Robertson was in the area when he observed a driver clearly using his phone as he drove. Deputy Robertson conducted a traffic stop to have a conversation over the suspect's phone usage; however, quickly noticed signs of intoxication. The driver admitted to having a few drinks prior to driving and a nearly consumed bottle of tequila was located in the vehicle. The driver was charged with driving under the influence and using a hand-held device while driving. He was held at Rappahannock Regional Jail on a \$1,000 secured bond.

Joshua Road, 5/4, 11:44 p.m. Sergeant A.T. Leckemby responded to some Tesla troubles. The caller advised a Tesla was stopped in the middle of the road. Sergeant Leckemby located the vehicle and made contact with the driver. The driver had signs of intoxication, admitted to consuming "a little bit" of alcohol, and open containers of alcohol were located in the vehicle. The driver attempted to get out of the DUI investigation by stating he wasn't driving and was using the "autopilot" function. That excuse did not work. The driver was charged with driving under the influence, drinking while driving, and refusal. He was held at Rappahannock Regional Jail without bond.

### **PUBLIC INTOXICATION**

When Deputy Helbling arrived, the unknown problem was quickly discovered to be an alcohol-based problem. The argumentative suspect had signs of intoxication and admitted to drinking earlier in the night. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.
