ASSAULT

Stafford High School, 63 Stafford Indians Lane, 5/6, 12:46 p.m. Deputy V.L. Powell was conducting her SRO duties when she was informed of a fight. One student assaulted another in a classroom. A third student jumped in to separate the predominant aggressor and was also assaulted. Criminal complaints for assault and battery are pending.

DUI

Intersection of Richmond Highway and Courthouse Road, 5/6, 12:01 a.m. First Sergeant D.W. Fetterolf was traveling Southbound behind a Chevy when they got stopped at the red light. When the light turned green and the Chevy driver didn't continue on, First Sergeant Fetterolf got suspicious. He attempted to make contact with the driver only to discover she was fast asleep. Deputy W.E. Trainor responded to assist and eventually the nappy rider woke up. She had signs of intoxication, admitted to consuming two shots, and three different kinds of hard liquor were located in the vehicle. She was charged with driving under the influence and refusal. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.

Wawa, 860 Richmond Highway, 5/6, 1:39 a.m. Deputy L.T. Ward was driving in the parking lot when a Ford nearly side-swiped his vehicle. After nearly being the victim of an auto accident, Deputy Ward made contact with the driver as Deputy C.A. Osborne responded to assist. The driver not only had signs of intoxication, but a witness had heard him admit earlier to being "half drunk" in celebration of Cinco de Mayo. On the Seis of May, the driver was charged with driving under the influence and refusal. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

Barrett Heights Road, 5/6, 3:32 a.m. Deputy E.L. Shelton was traveling on Garrisonville Road when he observed a Toyota run a stop sign. A traffic stop was conducted as additional deputies responded to assist. The driver had signs of intoxication and refused commands. After numerous attempts to have the driver comply without any results, OC spray was deployed. That did have results and the driver was detained. Within the vehicle a green leafy substance was located, but it wasn't basil. The driver was charged with driving under the influence, obstruction of justice,

failure to obey a stop sign, and refusal. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Area of Warrenton Road and McWhirt Loop, 5/6, 9:22 p.m. Deputy M.A. Holub responded to a drunk driver complaint. The caller advised a large work truck was failing to maintain the lane of travel and bumped a curb before coming to a dead stop in the middle of the road. Deputy Holub arrived and discovered the vehicle in question still blocking the road with an obstructed license plate. Deputy Holub made contact with the driver, who while he had signs of intoxication, only admitted to drinking Coca-Cola. While a rum and coke is a classic combination, drinking and driving isn't. A completely empty box of Modelo was also located inside the vehicle. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, drinking while driving, stopping on the highway, and having an improper display of a license plate. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

LARCENY

Jennifer Lane, 5/6, 1:40 p.m. Deputy R.L. Hubbard responded to a larceny. The victim had her wallet stolen from her vehicle. She would discover this when she received notice of a fraudulent transaction on one of her missing credit cards.

Walmart, 125 Washington Square Plaza, 5/6, 8:31 p.m. Deputy R.A. Kehoe responded to a larceny. Staff advised they had witnessed a female suspect steal hundreds of dollars' worth of household goods. Deputy Kehoe made contact with the suspect and the stolen items were recovered. She was charged with shoplifting and was released by the magistrate on personal recognizance.
