Ford Tyson "Toby" Humphrey
Killed in the Line of Duty
October 9, 1980

In memory of our fallen brother, **DEPUTY SHERIFF FORD TYSON** "TOBY" HUMPHREY, who lost his life in the pursuit of serving and protecting the citizens of Stafford County. On October 9, 1980, 26-year-old Ford Tyson "Toby" Humphrey was killed in the line of duty by a gunman while attempting to quell a domestic disturbance. Deputy Humphrey served his community as a Deputy Sheriff as well as a volunteer member of the Fredericksburg Rescue Squad.

Jason Edward Mooney
Killed in the Line of Duty
October 19, 2007

In memory of our fallen brother, DEPUTY SHERIFF JASON EDWARD MOONEY, who lost his life on October 19, 2007, in service to the citizens of Stafford County. Jason Edward Mooney, age 24, was killed in the line of duty while responding to a traffic accident on I-95. **Deputy** Mooney epitomized public service. He served in the United States Marine Corp in Al-asad, Iraq, had been a boy scout and was also a volunteer fireman with Stafford Company 2 at the time of his death.

The death of Deputy Toby Humphrey and the death of Deputy Jason Mooney serve to remind us of the inherent dangers of police work, and that any given shift may end abruptly in serious injury or death. May we focus not on the death of these two public servants, but their service that was best characterized by loyalty, fearless performance of duty, and faithful and honorable devotion to the principles of the Stafford Sheriff's Office.

The 350-year old Stafford County Sheriff's Office is one of the oldest in the Country and has consistently provided the citizens of Stafford the best law enforcement services possible. 




PROGRAMS AND SERVICES

The Sheriff is elected by the citizens of Stafford County and has an obligation to efficiently and effectively enforce the laws of the Commonwealth. He directs all Sheriff's Office duties and has final authority in matters of policy, operations and discipline.

RECEPTION DESK

All general inquiries go through the Reception Desk located in the main lobby of the Stafford County Public Safety Center, Ford T. Humphrey Building.

The Reception Desk is open to the public from 8:00 a.m. until 4:30 p.m. Monday through Friday for normal business purposes. A deputy is on duty at the Reception Desk from 4:30 p.m. -9:00 p.m. for walk-in emergencies. The Humphrey Building is in operation 24 hours a day, 7 days a week.



If you visit the Stafford County Public Safety Center, Ford T. Humphrey Building after the above-mentioned hours, there is a phone in the vestibule that will automatically connect you to the Emergency Communications Center.

COMMUNITY OUTREACH

The Stafford County Sheriff's Office fully recognizes the importance of community outreach and involvement. Opportunities to interact with the citizens of Stafford County allow the Sheriff's Office personnel a chance to better understand and serve the needs of the community. Numerous activities provide for a chance for the Sheriff's Office to work in partnership with a wide variety of citizens of all ages.



The Stafford County Sheriff's Office Community Programs include the

Cadet Program, Citizens' Police Academy, Project Life Saver, Neighborhood Watch, R.A.D., TRIAD, D.A.R.E. Basketball Fundraiser and National Night Out to mention a few. Car Seat inspections are



provided by deputies who are certified car seat technicians. The Crime Prevention Unit makes available DNA Kits and is a resource for the entire community. Crime reports are also available on the Sheriff's Office website www.staffordsheriff.com.

The D.A.R.E. program is taught by Stafford deputies in all 17 elementary schools in Stafford County and every high school and middle school has a full time School Resource Officer in the school every day. The high schools also have the Youth of Virginia Speak Out (YOVASO) leadership program that focuses on saving the lives of teenage drivers. Deputies assigned to the

Traffic Unit work with the school YOVASO Sponsor. Business Programs such as SCAM Busters, Business Safety Training and Home and Business Security Surveys are available as well as Conflict Resolution Training.



The Sheriff's Office has the Sheriff's Special Star Force Cadet Program. This program, the first of its kind in Virginia and possibly first of its kind in the nation, has been designed for young people, ages 13-22, with intellectual or physical disabilities (intellectual at a minimum) to give them an opportunity to experience the various duties of a law enforcement officer in a safe and hazard free environment. The SSSF Program is intended to be both educational and community service based

The Animal Control Division has a Disaster

Response Trailer that can house up to 48 cats or dogs. This trailer can be brought to any location in the county in case of a natural disaster or evacuation that result in home owners not having a place to house their pet during the event. This state of the art trailer is fully heated or air conditioned, depending on the time of the year. On a few occasions, the Disaster Response Trailer has also been sent to some area jurisdictions when a disaster or evacuation has occurred in their locality.

SHERIFF'S OFFICE HONORS

LAW ENFORCEMENT PERSONNEL FOR SERVICE



The Stafford County Sheriff's Office held its annual awards ceremony on Wednesday, June 4, 2014 to honor law enforcement personnel who have provided exemplary service to the community.

"Law enforcement officers put their lives on the line every day to serve and protect the citizens of Stafford," said Sheriff Jett. "The awards ceremony is an opportunity to formally acknowledge their extraordinary efforts and show our appreciation for their hard work and dedication."

Sheriff Charles Jett presented 45 honorees with awards for their actions and performance. The Medal of Valor was

given. It is the highest award given for Bravery & Heroism. The Silver Star was given and it is the second highest award for Bravery & Heroism. The Meritorious Award was given for emergencies in which a Sheriff's Office member demonstrated judgment, ingenuity or performance that clearly exceeds what is required and expected. The Commendation Award was given in the instances in which a Sheriff's Office member demonstrated exemplary service. A Traffic Safety Award was given to two deputies for traffic safety prevention, education and enforcement. A Community Award was given to two citizens for their many years of service as volunteers. A Unit Citation Award was given for overall excellence during a specific event or incident.

Individuals were selected by an Awards Committee consisting of personnel from the Operations, Criminal Investigations and Civil//Court Divisions and the Public Information Office. Individuals were nominated by other deputies or personnel of the Sheriff's Office. The committee evaluated the nominations based on the following criteria: bravery and heroism; exemplary performance which directly resulted in the solution of a major crime or crimes, or apprehension of a particularly dangerous criminal; and exceptional performance. The committee forwarded all nominations that they recommend to the Sheriff for his review and action.

The following personnel received awards:

2nd Lt. Brian Jacobs, 1st Sgt. Neal Robey & 1st Sgt. David Stout are all recipients of a **Medal of Valor** for knowingly placing their lives in peril of death while saving the lives of two fellow deputies who had been shot by a heavily armed male who had barricaded himself in his residence.

1st Lt. Joseph Pitman, Sgt. Joseph Bice, Sgt. William Walker, Detective Kurt McBride, Deputy First Class Kevin Lytle Jr., Deputy First Class Johnny Miller, Deputy First Class James Kingman, Deputy First Class Jason Forman, Deputy First Class William Johnson and Deputy First Class Bryan Mabry are all recipients of the **Silver Star** for knowingly placing themselves in great personal risk, under fire, while attempting to take a heavily armed subject into custody who was armed with numerous rifles and handguns.





Sgt. Brian Smyser and Senior Detective Angelo Irizarry are recipients of a **Letter of Commendation** for the investigation and ultimate conviction of 5 co-conspirators of the Bloodline Imperial Gang working both inside and outside the Rappahannock Regional Jail. These gang members were charged with gang participation, inciting riots and felony assault.

Senior Detective Nick Chiappini is a recipient of a **Meritorious Award** for leading an investigation that led to 99 indictments spanning the distribution of schedule II narcotics insurance fraud and involuntary manslaughter against a local doctor.

Sgt. Brian Smyser, Detective First Class Sarah Montgomery and Senior Detective Mark Steininger are recipients of a **Letter of Commendation** for their exemplary work on an investigation that led to 99 indictments spanning distribution of schedule II narcotic, insurance fraud and involuntary manslaughter against a local doctor.

1st Sgt. Eric Quinn and Sgt. Chris Cameron are recipients of a **Meritorious Award** for leading an investigation that led to the recovery of narcotics discovery of a body and three co-defendants who were charged with distribution of narcotics and 1st Degree Murder in a cold case that occurred in 2007.

1st Sgt. John Hughes and 1st Sgt. Chad Oxley are recipients of a **Letter of Commendation** for their outstanding efforts in solving a cold case from 2007 that led to three individuals being charged with the distribution of narcotics and 1st Degree Murder.

Senior Detective Edgar McCullough is a recipient of a **Letter of Commendation** for his exemplary efforts in solving over 100 related larceny cases involving several individuals.

Master Detective Mark Steininger, Senior Detective Nick Chiappini and Detective First Class Sarah Montgomery are recipients of a **Letter of Commendation** for their solving in what began as a burglary but eventually led to the arrest of multiple individuals involved in a heroin distribution conspiracy.

Deputy First Class Kevin Lytle Jr. and Deputy Joshua "Bo" Truslow are recipients of a **Letter of Commendation** for their outstanding efforts in solving numerous larcenies while also maintaining their roles as Patrol Deputies.

1st Sgt. Lee Peters, Deputy Bradley Cook, Deputy Rinaldy Mervil, Deputy First Class Walter O'Neal II, Officer Rusty Daymude (Aquia Harbour Police Department) and Deputy Rodney M. Stamm Jr. are all recipients of the **Meritorious Award** for using CPR to save numerous citizen lives in separate incidents.

Deputy First Class Robert Parsons is the recipient of a **Letter of Commendation** for his investigation that led to the arrest of a woman charged with forgery, larceny and obtaining money under false pretenses. These crimes occurred against an elderly woman living in a nursing home. This was done while still maintaining his role as a Patrol Deputy.

Master Detective Mark Steininger is a recipient of a **Meritorious Award** for his ability to keep a high risk suspect detained and under control at the same time a large dog had bitten and attached himself to Master Detective Steininger's hand.

Deputy First Class Brandon Gates is a recipient of a **Letter of Commendation** for his ability to investigate and solve four separate larceny cases while maintaining his responsibilities as a Patrol Deputy on the road.

Master Deputy Alex Smith is a recipient of a **Letter of Commendation** for his exemplary work in the solving of a case involving the rape of a juvenile victim. Master Deputy Smith's investigation led to the identity and location of the suspect.

Detective First Class Barry Surles is a recipient of a **Letter of Commendation** for his work that led to the arrest and conviction of a man who had raped his step-daughter multiple times over the last 10 years. The man's name was fictitious and he was also wanted for the sexual assault against two other juvenile victims outside of Stafford County.

Detective Patricia Tudor is a recipient of a **Letter of Commendation** for her outstanding efforts that led to the ultimate conviction of a mother for one count child neglect and the grandmother for 4 counts of cruelty to children. The convictions were for the deliberate burning of two young children's hands and arms over a hot stove.

Senior Detective Michelle Gibbons is a recipient of a **Letter of Commendation** for her hard work, many hours and investigative expertise in solving a home invasion robbery which involved the shooting of two victims.

Detective Patricia Tudor, Detective Darrell Wells and Senior Detective Michelle Gibbons are recipients of a **Letter of Commendation** for their exemplary efforts in solving a case involving the wish of a male subject to have sex with the complainant and her daughter. Ultimately a sting was set up that brought this individual to justice before he could hurt any young child.

1st Sgt. Robbie Grella, Sgt. Daren Volpe and Detective Kurt McBride are recipients of the **Meritorious Award** for the sting operation they initiated that brought to justice one of the most violent sex traffickers ever encountered in the eastern United States. These three men also received an award from the United States Attorney's Office – Eastern District of Virginia for this very important case.

Deputy Nick Zotos is a recipient of a **Letter of Commendation** for the outstanding way he handled an especially difficult incident that involved a suspect who was trying to kill himself after brutally attacking a female victim. The suspect stabbed himself and had slit his own throat and Deputy Zotos' efforts prevented the male suspect from dying.

1st Sgt. Lee Peters, Master Deputy Mike Powell Senior Deputy Burton Collins, Deputy First Class Jason Forman, Deputy First Class William Johnson, Deputy First Class Walter O'Neal II and Deputy Bradley Cook are recipients of a **Unit Citation** for their overall efforts in the areas of crash prevention, occupant safety and citizen education that significantly reduced the number and severity of crashes in Stafford County.

Deputy Brandon Gates is the recipient of the **Traffic Safety Award** for the Patrol Unit for his work in numerous areas of traffic safety on the roads of Stafford County.

Master Deputy Mike Powell is the recipient of the **Traffic Safety Award** for the Traffic Safety Unit for overall excellence in traffic safety and traffic safety education.







COMPASSION AWARD - Carl Wilcox








Number of Stafford County Public Schools




Stafford County Sheriff's Office Patrol Zones





The Stafford County Sheriff's Office budget is but one component of the overall Stafford County budget. For the FY 2014 the total County budget was \$255,015,445. Of that budget the Sheriff's Office budget was \$23,467,790 or 9% of the overall County budget.




The Sheriff's Office budget is broken into three main categories: Personnel, Operating Costs and Capital. Personnel deals with the salaries and benefits of the 244 Sheriff's Office employees. Operating Costs deal with the day to day operations of the Sheriff's Office to include training, technology, vehicles and fuel. Capital Costs include vehicles and associated equipment for the Sheriff's Office.






Crime Rate per 100 Residents







MAJOR PROPERTY CRIMES





Domestic Assaults Resulting in Arrest






Domestic Disturbance is defined as any conflict (verbal or physical) between household members that require law enforcement advice, guidance or intervention.





Auxiliary/Support Computer Aided Dispatch Events After Hours/Utility




Auxiliary/Support Computer Aided Dispatch Events Animal Control



Auxiliary/Support Computer Aided Dispatch Events Control Burns




911 Total Call Volume



Sheriff's Office Fire & Rescue Computer Aided Dispatch Events




ECC+911 TOTAL CALL VOLUME




CALLS FOR SERVICE

Calls for Service Requiring Direct Response by Sheriff's Office Personnel





Each year, deputies put their lives on the line to protect our community. The graph below shows the number of assaults on deputies over the past 5 years.


Assaults on Deputies

ANIMAL CONTROL

The Animal Control Division provides the citizens of Stafford County with a comprehensive program that deals with a wide range of opportunities and solutions to the proper care of animals in Stafford County.

In 2014 the Animal Shelter received numerous donations to assist with the operation of the shelter. The shelter either fully funded or assisted in funding the spaying and neutering of 158 dogs and cats. This was done with 100% donated money. Several Eagle Scout projects provided the shelter with newly built dog houses to be given out to families to help ensure that animals are properly and adequately sheltered when outside. Vet care donations were also made by the public that greatly assisted with the expense of veterinary care.



Food donations were received from school groups, businesses, birthday parties and generous individual citizens. Each animal at the shelter is assessed to determine what food would be the most appropriate for that animal's growth and development. Food is also given to families who may have trouble paying for animal food but have a family pet.

The shelter has had the assistance of caring and devoted volunteers (citizens & county employees) who donate their time and efforts in several ways. Dog walkers were used to take dogs outside the shelter, giving the dogs a chance to interact and exercise. A professional photographer volunteered her time, photographing animals for adoption and public events. The shelter also partners with students from the Brooke Point High School Achieve Program, preparing students for the working world outside of school.

The Animal Control Division also hosted a hunter safety class for the general public; a class that is mandated for all hunters. In addition, a basic boater safety class was hosted by the Animal Control Division and presented by the Auxiliary Coast Guard. That class will also become mandatory in the near future.

In 2015 the Animal Control Division will be developing programs that will recruit more Foster Families to adopt animals when the shelter is in need of space. A plan will be implemented that will create an area to release cats, during the day, that will allow the cats time to exercise and socialize and an effort will be made to recruit additional volunteers to walk and exercise dogs.




COURT SERVICES DIVISION

The Stafford County Sheriff's Office Division of Court Services/Civil Process is staffed with 25 members that include the Division Commander Captain, a 1st Lieutenant, 1st. Sergeant, 2 Sergeants, 20 Deputies and 1 Senior Administrative Assistant. This Division provides a number of services such as court security for 7 courts (that include 3 Circuit Courts, 2 General District Courts and 2 Juvenile & Domestic Relation Courts), prisoner transportation and the processing of all legal civil procedures.



In 2014 the Court Services Division handled 37,278 civil processes, 884 evictions, transported 860 prisoners, 107 extraditions and 93 mental health individuals. In addition, in 2014 deputies screened 187, 416 people coming into the courthouse, provided 1,127 finger print services for citizens in Stafford County and served 456 warrants.




INTERNAL AFFAIRS

The image of the Stafford County Sheriff's Office depends on the personal integrity and discipline of all the Sheriff's Office employees. The Sheriff's Office encourages citizens to bring forward legitimate grievances regarding misconduct by employees. The Sheriff's Office investigates all complaints made by citizens. In addition, 50% of the complaints investigated by the Sheriff's Office are internally initiated by the Sheriff's Office. It is important to note that the Sheriff's Office is pro-active in investigating its own and ensuring the public that only the highest standard is acceptable.


Upon completion of an investigation the results shall be classified as the following:

- A. **Unfounded:** The allegation is demonstrably false. There is no credible evidence to support the charge, or, the employee charged was not involved, or, the individual was not a member so the Stafford County Sheriff's Office.
- B. **Exonerated:** The incident occurred, the employee's action were justified, lawful and within the Sheriff's authority and policy.
- C. **Not sustained:** An incident occurred, but there is not sufficient evidence to prove the charges; thus the Sheriff's Office cannot proceed with the investigation or take any action against the employee.
- D. **Sustained:** The allegations is supported by sufficient evidence to indicate that the employee committed one or more violations of policy and/or procedure, violations of law, or the investigation disclosed other violations.

In 2014 the Stafford County Sheriff's Office responded to over 145,348 calls for service. The 36 personnel complaints account for less than .025% of all the calls the Sheriff's Office personnel responded to.



In 2014 the Sheriff's Office received thirty six (36) citizen prompted complaints that led to personnel investigations. The following are the dispositions of those allegations.




PUBLIC INFORMATION OFFICE

The Public Information Office was responsible for the following in 2014:

- Development of a 30 second PSA, featuring Sheriff Jett & Commonwealth's Attorney for Stafford County, dealing with Heroin and its effects on the user and the user's family. PSA's shown on all local cable stations as well as BET, FX, MTV, Hallmark, TLC TNT and VH1.
- Assisted with the development of a 4 minute video featuring a heroin user and his father and the negative effects heroin use has on a family.
- Public spokesman for the Stafford County Sheriff's Office.
- Responsible for daily contact with all forms media to include, print, television & radio.
- ▶ Subject to notification 24 hours a day/365 days for media needs.
- Wrote the Sheriff's Office Annual Report.
- Responsible for all Sheriff's Office award ceremonies including chairing the Selection Committees, ceremony development, writing award descriptions, selection of venue, organization of award dinners and Master of Ceremonies.
- Organization and write up of national award nominations for individual personnel.
- Respond to requests from the public for information on a daily basis.
- Assist various Sheriff's Office Divisions with dissemination of information to include lost children/adults, wanted criminals, Sheriff's Office programs and initiatives.
- Organize interview requests from the media for SCSO personnel.
- Act as Sheriff's Office photographer.
- Speak at local organizations about the efforts of the Sheriff's Office.

A supervisor will assist you in completing a report to outline the incident and complaint regarding a deputy or civilian employee. You will be asked for information that identifies you and for information as to where you may be contacted.

You will be notified, by letter, that your complaint has been received and is under investigation by the Sheriff's Office. You may be contacted for further information.

In most cases, the investigation will take less than sixty days; however, should it take longer, you will be notified. When the investigation is complete, you will be notified of the disposition.
