In memory of our fallen brother, DEPUTY SHERIFF

FORD TYSON "TOBY" HUMPHREY, who lost his life in the pursuit of serving and protecting the citizens of Stafford County. On October 9, 1980, 26-year-old Ford Tyson "Toby" Humphrey was killed in the line of duty by a gunman while attempting to quell a domestic disturbance. Deputy Humphrey served his community as a Deputy Sheriff as well as a volunteer member of the Fredericksburg Rescue Squad.

In memory of our fallen brother, DEPUTY SHERIFF

JASON EDWARD MOONEY, who lost his life on October 19, 2007, in service to the citizens of Stafford County. Jason Edward Mooney, age 24, was killed in the line of duty while responding to a traffic accident on I-95. Deputy Mooney epitomized public service. He served in the United States Marine Corp in Al-asad, Iraq, had been a boy scout and was also a volunteer fireman with Stafford Company 2 at the time of his death.

The death of Deputy Toby Humphrey and the death of Deputy Jason Mooney serve to remind us of the inherent dangers of police work, and that any given shift may end abruptly in serious injury or death. May we focus not on the death of these two public servants, but their service that was best characterized by loyalty, fearless performance of duty, and faithful and honorable devotion to the principles of the Stafford Sheriff's Office.

The Stafford Sheriff's Office is dedicated to providing the best law enforcement services possible. It is a challenging mission but one that we consistently strive to accomplish. Every citizen deserves to live in a safe community. For this reason we want to ensure that Stafford County continues to be one of the safest.





2015 Organizational Chart












Programs and Services

Community Outreach

The Stafford County Sheriff's Office fully recognizes the importance of community outreach and involvement. Opportunities to interact with the citizens of Stafford County allow the Sheriff's Office personnel a chance to better understand and serve the needs of the community. Numerous programs provide the Sheriff's Office an opportunities to work in partnership with a wide variety of citizens of all ages.



The Stafford County Sheriff's Office Community Programs include the Cadet Program, Citizens' Police Academy, Project Life Saver, Neighborhood Watch, R.A.D., TRIAD, D.A.R.E. Basketball Fundraiser and National Night Out to mention a few. Car Seat inspections are provided by deputies who are certified car seat technicians. The Crime Prevention Unit makes available DNA Kits and is a resource for the entire community. Crime reports are also available on the Sheriff's Office website www.staffordsheriff.com.

The D.A.R.E. program is taught by Stafford deputies in all 17 elementary schools in Stafford County and every high school and middle school has a full time School Resource Officer in the school every day. The high schools also have the Youth of Virginia Speak Out (YOVASO) leadership program that focuses on saving the lives of teenage drivers. Deputies assigned to the Traffic Unit work with the school YOVASO

Community Outreach



The Sheriff's Office developed the Sheriff's Special Star Force (SSSF) Cadet Program. This program was the first of its kind in Virginia, and possibly the first of its kind in the nation. The SSSF is designed for young people with intellectual challenges, ages 13-22. Cadets experience various duties of a law enforcement officer in a safe and hazard free environment. The SSSF Program is intended to be both an educational and community service based program.

The Animal Control Division has a Disaster Response Trailer that can

house up to 48 cats or dogs. This trailer can be brought to any location in the county in case of a natural disaster or evacuation resulting in home owners not having a

place to house their pets. This state of the art trailer is fully heated or air conditioned, depending on the time of the year. On a few occasions, the Disaster Response Trailer has also been sent to other jurisdictions when a disaster or evacuation has occurred.



The Sheriff's Shopping Spree provided \$100.00 for 100 excited children, giving them the opportunity to purchase toys and clothes for themselves. Keeping in the Christmas spirit, the children also purchase gifts for family members. Close to \$10,000.00 was donated in 2015 by Dougherty's Tavern and an anonymous individual, to support this special program.

Volunteer Services

The Stafford County Sheriff's Office recognizes, with great appreciation, the efforts of the many individuals who volunteer their time. In 2015 volunteers provided 8334 hours of service at a taxpayer savings of \$244,382.00



Sheriff's Office Honors



The Stafford County Sheriff's Office held its annual awards ceremony on Thursday, May 21, 2015 to honor law enforcement personnel who have provided exemplary service to the community.

"Law enforcement officers put their lives on the line every day to serve and protect the citizens of Stafford," said Sheriff Jett. "The awards ceremony is an opportunity to formally acknowledge their

extraordinary efforts and show our appreciation for their hard work and dedication."

Sheriff Charles Jett presented 50 honorees with awards for their actions and performance. Meritorious Awards were given for emergencies in which a Sheriff's Office member demonstrated judgment, ingenuity or performance that clearly exceeds what is required and expected. Commendation Awards were given in instances where a Sheriff's Office member demonstrated exemplary service. Traffic Safety Awards were given to two deputies for traffic safety prevention, education and enforcement. Community Awards were given to two citizens for their long time support of the Sheriff's Office. A Unit Citation Award was given for overall excellence during a specific event or incident.

Individuals were selected by an Awards Committee consisting of personnel from the Operations Division, Criminal Investigations Division, Civil/Court Division and the Emergency Communications Center. Individuals were nominated by other deputies or personnel of the Sheriff's Office. 


The Sheriff's Office divides Stafford's 270 square miles into four patrol areas.


County Budget Information




The Stafford County Sheriff's Office budget is but one piece of the overall Stafford County budget. For the FY 2015 (July 1, 2014 - June 30, 2015) the total County budget was \$262,739,908.

The Sheriff's Office budget was \$24,485.910 or 9.3% of the overall County Budget.








Personnel costs include the salaries and benefits of the 262 Sheriff's Office employees.




These statistics include proactive policing and investigation leading to arrests in certain categories that may otherwise go unreported.


For example, Human Trafficking, Pornography, Narcotics and Gambling arrests are usually the results of proactive policing and not citizen-reported crimes.

The investigations done by our agency increase the number of arrests made.


Crime Statistics for Calendar Year 2015




Crime Statistics - Number of Arrests by Calendar Year




Crime Statistics - Major Property Crimes by Calendar Year



Crime Statistics - Types of Violent Crimes by Calendar Year




Crime Statistics - Domestic Disturbances & Assaults



Reports of domestic disturbances decreased in 2015 as did arrests for domestic assaults.















Total Call Volume to Emergency Communications Center




Call Volume Comparisons Sheriff Office/Fire & Rescue



911 Total Call Volume




Call Volume for Control Burn Events



Call Volume for After Hours Utility Support





Call Volume After Hours Animal Control



Calls for Service


Calls for Service Requiring Direct Response By Sheriff's Office Personnel







Each year, deputies put their lives on the line to protect our community. The graph above shows the number of assaults on deputies over the past five years.

Animal Control Statistics








Internal Affairs

The image of the Stafford County Sheriff's Office depends on the personal integrity and discipline of all the Sheriff's Office employees. The Sheriff's Office encourages citizens to bring forward legitimate grievances regarding misconduct by employees. The Sheriff's Office investigates all complaints made by citizens. In addition, 48% of the complaints investigated by the Sheriff's Office are internally initiated by the Sheriff's Office. It is important to note that the Sheriff's Office is pro-active in investigating its own and ensuring the public that only the highest standard is acceptable.

Upon completion of an investigation the results shall be classified as one of the following:

- A. **Unfounded:** The allegation is demonstrably false. There is no credible evidence to support the charge, or, the employee charged was not involved, or, the individual was not a member of the Stafford County Sheriff's Office.
- B. **Exonerated:** The incident occurred, the employee's actions was justified, lawful and within the Sheriff's authority and policy.
- C. **Not sustained:** An incident occurred, but there is not sufficient evidence to prove the charges; thus the Sheriff's Office cannot proceed with the investigation or take any action against the employee.
- D. **Sustained:** The allegations are supported by sufficient evidence to indicate that the employee committed one or more violations of policy and/or procedure, violations of law, or the investigation disclosed other violations.



In 2015 the Stafford County Sheriff's Office responded to 139,318 calls for service. The 51 personnel investigations account for less than .037% of all the calls responded to by Sheriff's Office Personnel. Of the 51 cases investigated for policy violation and complaints, 37 resulted in a sustained violation.

Public Information

- Public spokesman for the Stafford County Sheriff's Office.
- Responsible for routine contact with all media outlets.
- Disseminates information on lost children/adults, wanted criminals.
- Subject to notification 24 hours a day/365 days for media needs.
- Respond to requests from the public for information on a daily basis.
- ▶ 44 TV interviews, 24 radio interviews, 373 articles were written in 2015.
- Act as Sheriff's Office photographer, videographer and social media coordinator.

Many times the citizen doesn't know to whom they should speak, or where they should write to express their sentiments of appreciation.
